Bracken County Schools' Title I Plan emphasizes the need for our students to have successful Transition. The District wanted to use Title

IV to help supplement those goals with activities to address those needs. Bracken County is located in rural Kentucky. Our students have limited exposure to different career paths, college campuses, and other resources that would open door to successful transition and be college or career ready. Bracken County wants to use this portion of the Title IV to provide resources to our counselors to provide Career and College counseling and guidance. In addition to providing our counselors with additional PD on college and career counseling we also want to engage our parents and students. Parents and students will be involved in the

following activities:

- Counseling/Guidance/Scheduling sessions on dual credit opportunities
- ILP Development (Xello Software will be used)
- Counseling/Guidance sessions on career, financial aid, college planning
- Guidance Sessions on college applications
- Guidance Sessions on Financial Aide (FAFSA Workshops)
- Field Trips to visit college campuses and career job sites.
- Transition Programs to assist with CTE and College enrollment
- Scheduling seminars to achieve college and career success
- Attendance at college and career fairs
- Persistence to Graduation Activities and Strategies


Safe and Healthy Students

Bracken County Schools would like to utilize the Safety and Healthy Student Section of this grant to initiate the Safe Schools Training Program for faculty and staff. This is an on-line professional development system that produces courses that faculty and staff are trained in to promote student safety. Topics include but not limited to PBIS, Bullying, Youth Suicide, Active Shooter, Child Abuse Reporting, Confidentiality, and De Escalation Strategies, Restraint and Seclusion, and FERPA. Guidance Counselors in the school district will also help to implement Safety and Healthy initiatives.

Bracken County Schools would also like to partner with the Bracken County Sheriff to provide a District School Resource Officer to provide additional security and safety measures for our students.
