Mr. Smith shared information regarding the Toyota van lease, the lease ends December 11th. Toyota has given the buyout of \$16,847.00. Mr. Smith would like to purchase the van. Administrator Reports

Mr. Smith shared information regarding current quarantine numbers of three students that are due to parents contact tracing, nothing in school related. Also shared that our school nurse has been approved to administer testing should the need arise for a student. Mr. Smith shared that he will put out an RFQ for architect input for building a new school gymnasium and classrooms. He hopes to have information for the board next month. He also shared that he is looking into the recent FEMA funds that may be available, and again hopes to bring information next month to the board.

Mr. Curtis reported that current high school enrollment is 239 with 94.74% attendance rate. Parent / Teacher conferences last month went rather well. Jr. Class held a decade's dance last week that was a lot of fun for the kids. FFA national convention was recent and attended by 6 of our students. This week we have a choir concert and also will hold a choir vocal clinic and concert. The HS band will leave this Saturday for their Nashville trip. The HS Band will perform at Graceland on Tuesday, November 23rd at 1:30PM, this will be live streamed on our Facebook page. Fall sports finished up with great seasons, winter sports have started, and currently both boys and girl's teams have good participation numbers. Regular season for basketball will begin the week after Thanksgiving. The baseball pancake breakfast was this past weekend with a good turnout.

Mrs. Eifert reported the elementary enrollment is now at 257 students with an attendance rate just above 96%. Parent / Teacher conferences went well last month for staff. Christmas concerts will be December 14th with grades K-3 and the 16th with grades 4-6. Youth basketball has started both gyms are busy nightly.
