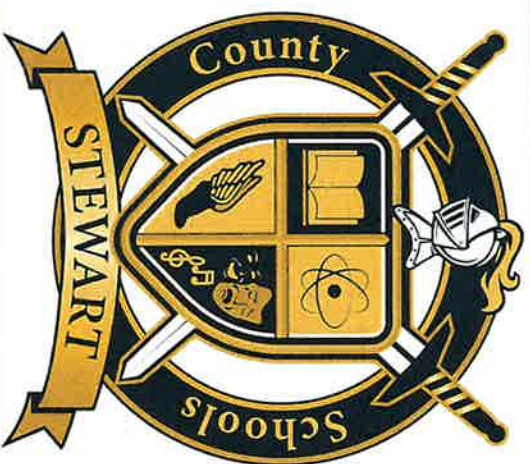


Road Map to School Board Presentation

Substantial Spread

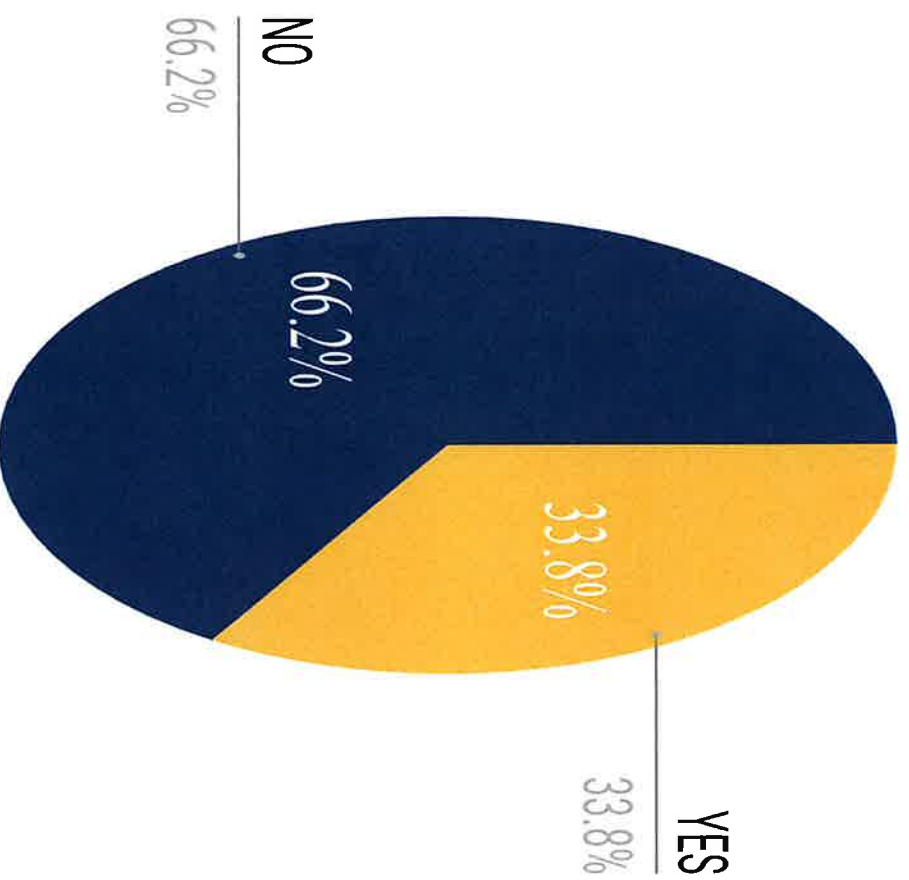

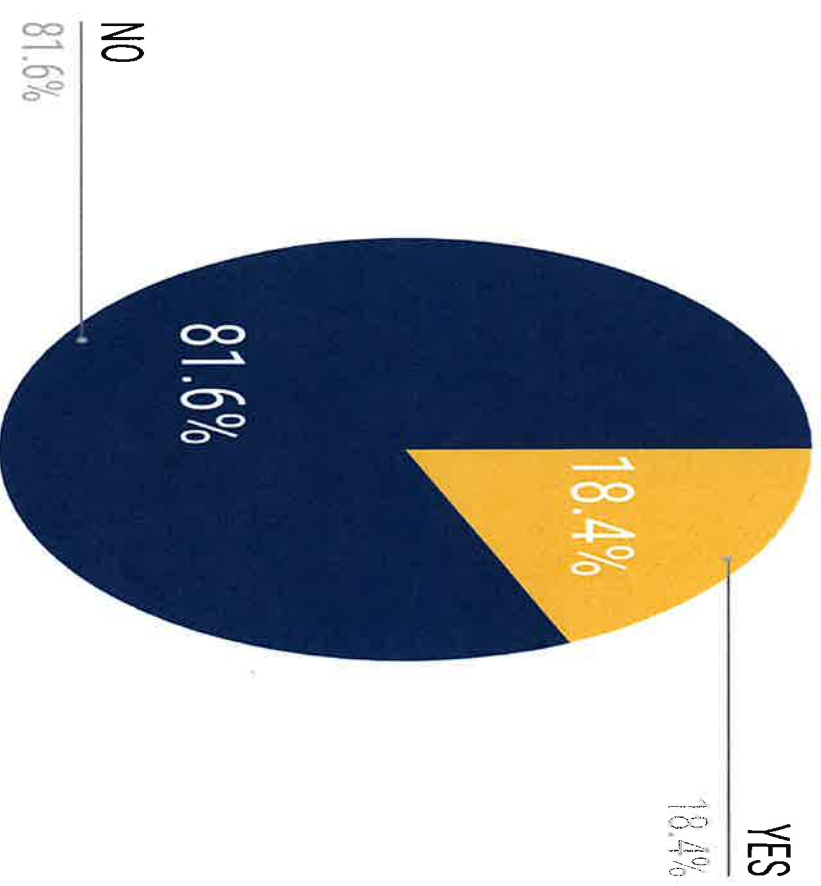

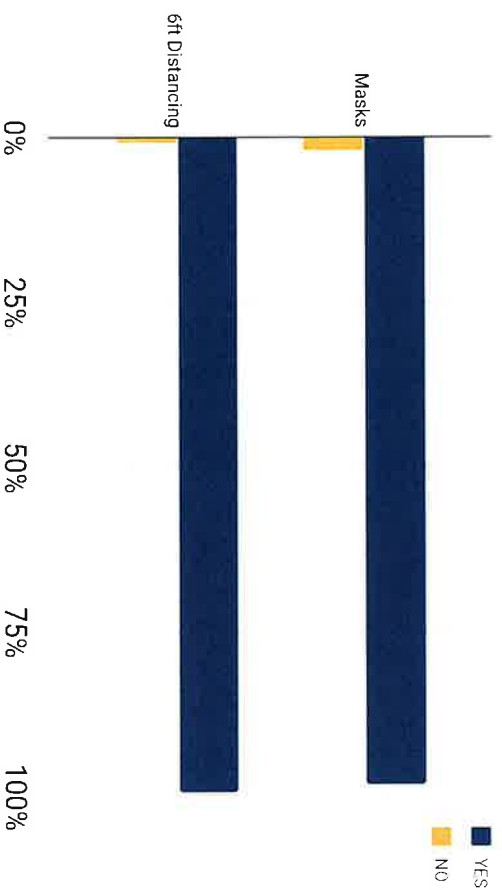
Are you comfortable returning to school following the regular schedule?

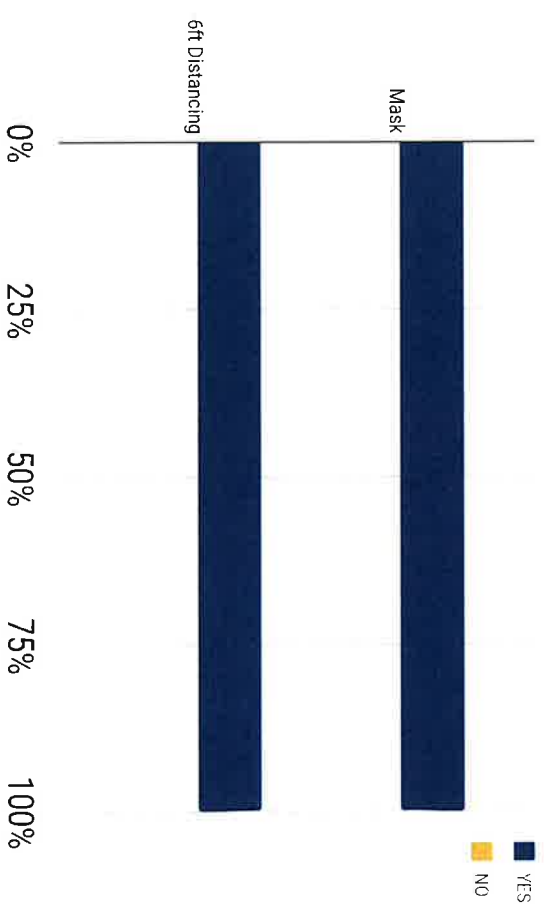

Alternating Models

A/B Schedules (Plan B)

With the A/B Schedules, half of the students would come to school on A Day and the other half of the students would come to school on B Day. Families that live in the same household will come on the same days.

Option 1

Students will attend face-to-face instruction at school alternating A and B Day with Distance Learning on Fridays. School would be dismissed at 2:30 p.m. each day for daily deep cleaning.

Option 2

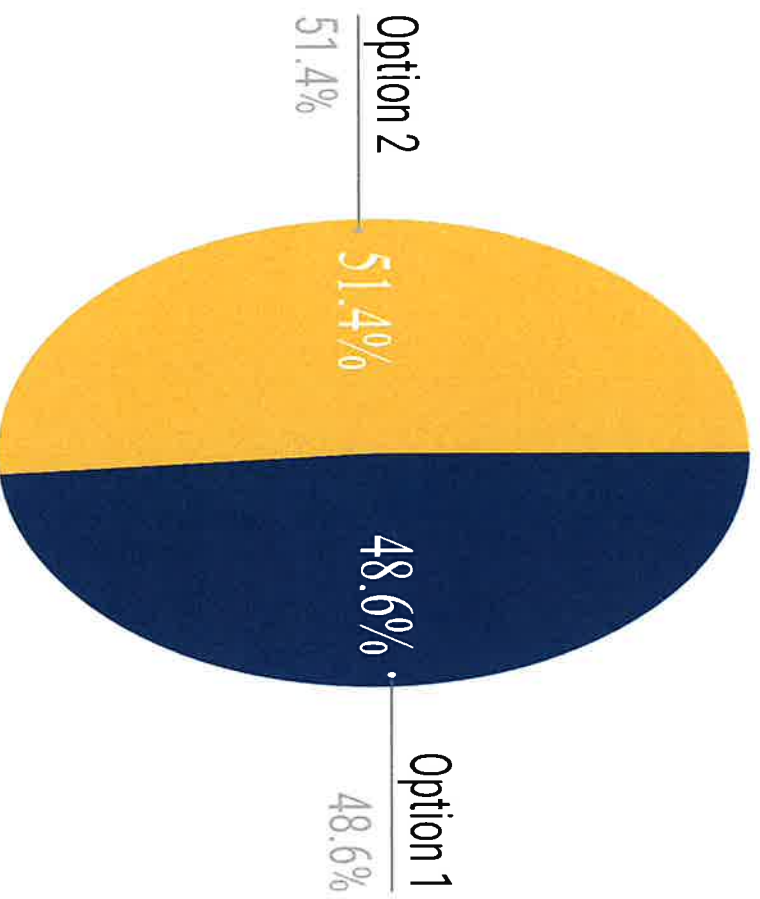
Students will attend face-to-face instruction at school two days back to back with an assigned A or B Group and Distance Learning on Fridays. School will be dismissed at 2:30 p.m. each day for daily deep cleaning.

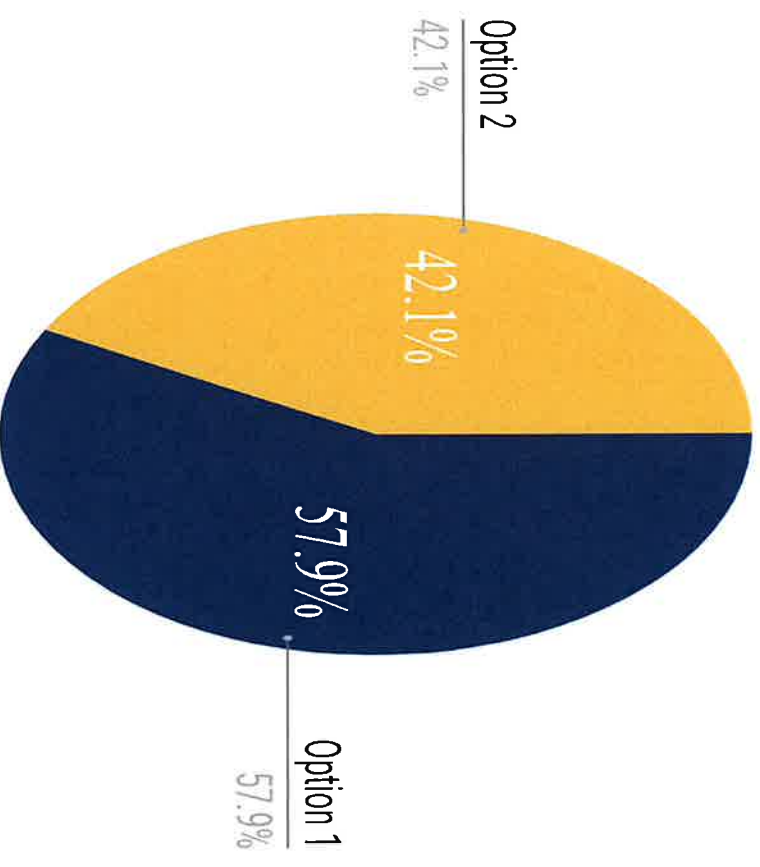

CDC Universal Precautions

- Temperatures checked prior to boarding the buses by the Monitor.
- Social distancing will be implemented on the buses (see Transportation Dept.)
- Masks issued to any student who don't have a mask on at the bus pickup.
- Social distance markers when exiting the busses to be followed throughout the building.
- Hand sanitizer in every room to be used by each student prior to entering the class.
- Lunch will be served in classes.
- Non-self contained teachers will change classes using a cart for materials. (3rd-8th)
- Recess (K-5) and Brain-breaks (6-12) will be provided daily following social distancing at designated times.
- Have an Isolation Room.

Safety

Regular Schedule

- Follow Universal Precautions
- Everyone wear masks
- Maintain social distancing – 6 feet
- Implement social distancing from uploading buses to all areas of the building.
- Don't allow students to share anything – individual supplies
- Utilize one to one devices
- Deep sanitizing using spray guns

Challenges

- Maintaining Social Distancing in class and on the buses
- Isolating sick students
- Checking temperatures

Alternating Schedule

- The same procedures will be followed as with Regular schedule; however, maintaining social distancing would be more achievable.

Challenges

- Delivering lunches to students not in attendance (see Child Nutrition)
- Providing Virtual Learning to all students.(see Technology Plan)

Positive Cases At School

Follow CDC Guidelines.

Quarantine the person for required number of days.

Deep clean the room.

Notify/quarantine people who have been exposed.

Require testing before returning to school/work

Deep Cleaning the Building

We have seven custodians.

Regular Schedule

- Custodians will be trained on sanitizing the building.
- Cleaning supplies have been ordered for the 1st Nine Weeks.
- Spray guns will be used daily in classes.
- Classrooms will be deep cleaned daily.
- Signs will be posted for custodians to document the times the restrooms were cleaned and by whom.

Alternating

- Same as Regular except for listed below
- Three custodians will report at 6:30 a.m.
- Clean will start at 2:30 on the alternating day.

Virtual

Same as Regular except for below:
Occupied rooms will be deep cleaned daily.

Transportation Plan

We have 10 Regular Buses and 2 Special Needs buses

Regular Schedule

- Monitors take students temperature.
- Masks will be required to board the buses.
- Masks will be provided for students who do not have one.
- Students will be seated as a family following the 6 Feet Distancing as much as possible and multi-routes will be required.

Challenges

- Maintaining social distancing

Alternating Schedule

- Same as Regular Schedule
- Students will be grouped and assigned in two groups for pickup
 - A and B
- Maintaining social distancing will be more achievable.
- There will be multi routes required

Child Nutrition Plan

Regular Schedule

- Students will eat break and lunch in classes
- Paper products will be used with pre-wrapped utensils.
- Paraprofessionals will be used to support lunch deliveries.

Alternating or Virtual Schedule

- Cold lunches will be provided to students that are not in school.
- Bus drivers and monitors will be used to deliver meals to students that are not at school or during Virtual Schedule
- Multi meals to will be provided to students to reduce trips.

Technology

We are 1 to 1 in the Middle School and High School

- Devices will be issued to all

students in grades 2nd through 12th. and parents will sign a contract to receive the device.

Challenges

- Connectivity in certain areas
- Devices are on backorder

- Students Grade Level Digital Dashboard
- Online Registration - Permission Click
- Hot Spots in select communities
- Ensure that all teachers are proficient with (Google Suite) Google Classroom, Google Meet, Zoom, Google Doc
- Device distribution- Pre Planning

Setup Model Classroom Pre-Planning

There are currently 61 Special
Education students in Pre-K - 12th
Grade.

Alternating or Virtual Schedule

- ▶ Devices will be issued to all students (ipads still needed for 1st Grade and Leap Frogs needed for Pre-K)
- ▶ Engenuity (Online Platform) will be used in all schools grades k-12.
- ▶ Paraprofessionals will teach small groups in Pre-K-3.

Grading

Special Education

There are 61 Special Education Students

Regular Schedule

Follow General Education Except:

Special education services (i.e. co-teaching, small group, related services) will be provided with safety precautions in place.

Alternating /Virtual Schedule

Follow General Education Except:

Special education services (co-teaching, small group, speech and related services-OT, PT) will be provided via Google Meet/Zoom.

Small Group Instruction will be scheduled based upon the students' need.

Attendance

Regular Schedule

Attendance has been waived for students during the 20-21 School Year.

Follow CDC Guidelines and Health Provider Instructions.

Educate students virtually who contracted COVID 19 and count them present.

Staff who contract COVID 19 will be on sick leave with pay.

Alternating Schedule

Students on the Alternating and Virtual schedules will be counted present each day; however, students are required to complete assignments.

Discipline

Follow Code of Conduct.

Follow Multi Tier System For Support (stage of discipline and academic support).

Have an Isolation Room for minor disruptive behavior.

Provide Virtual Learning to

- Continuous disruptive students
- students who are assigned to the Alternative School

Other

Athletics

- There are 11 coaches on staff.
- [Infectious Disease Plan](#) for COVID-19 has been created.
- Safety Supplies have arrived.
- Athletes will be screened daily before they are cleared to participate in Summer Workouts.
 - Temperatures will be checked
 - There is a "no sharing rule".
- Workout stations will be sanitized after each single use.
- Athletes are required to bring their own water bottles.
- Athletes are required to arrive dressed for workouts.
- All water fountains in the gym are closed.
- Locker Rooms are closed.
- In person workouts are set up following social distancing.
- Virtual workouts are in the planning stage.

21st CCLE Plan

Regular Schedule

- Meet Monday through Thursday 3 hours per day.
- 195 students required
- Follow universal precautions - masks, social distancing
- Supper Plan
 - Students will eat in the classroom.
 - Teachers will transition to the students in ES/MS
- Transportation Plan will follow social distance

Alternating Schedule

- Start time will be coincide with school dismissal.
- Supper start time will be adjusted to align with early release (2:30)
