Junior high and high school students will be able to participate in the Breakfast Before the Bell program and Breakfast After the Bell programs. Students at our elementary schools will be able to participate in the Breakfast after the Bell program during Homeroom.

This letter is to inform you that your child(ren) will be able to participate in these meal programs without having to pay a fee or submit an application. You will be asked to complete a Household Information Survey. Your participation is essential in order for us to provide the Department of Education with the information it needs to ensure our school/district will continue to receive critical state funding.
