A. General

The contractor shall complete alterations to the existing sound system as specified with all equipment and accessories required to provide a complete operating system.

The system shall be installed by a factory trained sound system contractor for the equipment manufacturer.

The entire system shall be guaranteed for a period of one (1) year from the date of final acceptance of the installation and any defective equipment or parts shall be replaced or repaired, during the guaranteed period, at no cost to the owner.

The manufacturer and model numbers are provided to establish quality of equipment and operating requirements for the system.

Any proposed substitution of equipment must be approved by the architect within ten days prior to bid date. No substitution will be permitted after the project bid date.

All wiring shall be in accordance with the local national codes.

B. Console

The contractor shall replace the existing Dukane Console with (1) CAREHAWK CH1000 central controller (1) CAREHAWK AP1 admin console (1) SS32 switch (1) AD2W two wire adapter. Contractor shall connect all existing zones and all new zones to new console for a complete operating system. All existing call-in switches, digital clocks, speakers, etc. are to remain.
