- 01. To determine the salaries of the School Board and fix the compensation of any other officers or agents of the District. These salaries are included in Article 04.
- 02. To hear the reports of agents, auditors, committees or officers chosen and pass any vote relating thereto.
- 03. To see if the School District will vote to approve the cost items included in the collective bargaining agreement reached between the Pittsburg School District and The Pittsburg Education Association which calls for the following increase in salaries and benefits at the current staff level over the amount paid in the prior fiscal year:

2023-2024	\$ 54,956.00
2024-2025	\$ 41,554.00
2025-2026	\$ 41,457.00

and further to raise and appropriate \$54,956.00 for the upcoming fiscal, such sum representing the additional costs attributable to increases in salaries and benefits required by the new agreement over those that would be paid at current staffing levels. The School Board recommends this appropriation.

- 04. Shall the Pittsburg School District, if article #3 is defeated, authorize the governing body to call one special meeting, at its option to address article #3 cost items only?
- 05. To see if the School District will vote to raise and appropriate the sum of THREE MILLION, SIX HUNDRED NINETY-SEVEN THOUSAND, SEVEN HUNDRED EIGHTY-NINE DOLLARS (\$3,697,789.00), for the support of schools, for the payment of salaries for the school district officials and agents, and for the payment for the statutory obligations of the District. This article does not include appropriations voted in any of the other warrant articles. The School Board recommends this appropriation. (Majority vote required)
- 06. To transact any other business that may legally come before this meeting.
