The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs. **Eligible Students included domestic students – citizens, permanent residents, refugees, asylum seekers, DACA recipients, DREAMers, and undocumented students. Incarcerated students have been excluded. Each Institution establishes eligibility individually, Reid State Technical College distributed to all credit students which includes Dual Enrollment. It is required by law, that the amount be different for those who have a greater need. Reid State Technical College determined need based on EFC. Students with an EFC <= 5711 received \$50.00 more than those with and EFC >= 5711.**

a. CRRSAA (HEERF II) - Spring Semester 2021

The College awarded 196 Pell Recipients \$745.20/student and 103 Non-Pell students received \$695.20/student.

Total awards to students were \$217,664.00.

b. American Rescue Plan (HEERF III) Summer Term 2021

The College awarded 134 Pell Recipients \$1,332.81/student and 58 Non-Pell students received \$1,282.81/student. The College awarded \$253,000 to all eligible students for Summer Term 2021,

Total awards to students were \$253,000.00.

American Rescue Plan (HEERF III) Fall Term 2021

The College awarded 214 Pell Recipients \$840.00/student and 145 Non-Pell students received \$790.00/student. The College awarded \$290,526.42 to all eligible students for Fall Term 2021,

Total awards to students were \$290,526.42.

American Rescue Plan (HEERF III) Spring Term 2022

The College will award the Spring 2022 students the final distribution of American Rescue Plan (HEERF III) Student Funds in April 2022.

The total awards to students for Spring 2022 will be \$216,195.58.
