The Greenville Area School District solicits bids for **Custodial Supplies** for use in the District during the 2026-2027 school year. Specifications as listed for individual items on the attached list have been taken from the manufacturer's specification list. **Bid prices shall include delivery to the Greenville Area School District.**

CONDITIONS UNDER WHICH BID SHALL BE MADE

1. Jobbers shall submit bids on the forms provided by the School District or on comparable forms in which the items are listed in the same order.
2. The items on our bid forms are separated by lines. If these lines do not print out on your forms, please make sure your bid amounts are clearly lined up with the item number you are bidding on.
3. The School District reserves the right to omit items as they so desire.
4. Billings *must* be stated as of July 1, 2026, or later. No payments can be made until after July 1, 2026.
5. Any questions regarding specifications may be referred to Josh Spaltro, Custodial Foreman, at (724) 588-2500, ext 2198. Leave a message and he will get back to you.
6. Please see the accompanying "Read Me" document for further conditions.

DELIVERY OF MATERIALS - STANDARDS AND INSTRUCTIONS

1. Delivery shall be made after May 1, 2026, but no later than June 1, 2026. If you have a problem with the delivery schedule, please contact Josh Spaltro at the above number.
2. The Business Office must be notified at least TWO (2) days in advance of shipment (724-588-2500, extension 2304).
3. Delivery will be drop-shipped to the address indicated on the

purchase order.

4. All deliveries shall be unloaded by the bidder's staff (forklift) and freight company's staff (pallet jack to tailgate). Unloading personnel are available from 8:00 A.M. to 2:00 P.M. daily Monday through Friday.
5. The proposal shall include freight.
6. Height of pallet loads when double stacked, including pallets, will not exceed 109".
7. **Delivery will be refused if incoming shipment does not comply with bidder's delivery standards.**

Bids must be submitted in sealed envelopes and clearly marked. The bid must be in the Office of the Business Manager, Greenville High School, 9 Donation Road, Greenville, PA 16125, on or before 12:00 Noon EDT, March 20, 2026. Bids will be officially opened for tabulating March 20, 2026, at 1:30 P.M. EDT, in the Business Office. Bids may be awarded at the regular Board Meeting to be held April 20, 2026, at 6:30 P.M. EDT.

The Board of Directors reserves the right to reject any or all bids and to waive any informalities in the bidding, as well as the right to enter into any contract which will be in the best interest of the School District.

2. If you consider your product to be “equal” to those listed, please send any documentation, including cut sheets, glossies, or other manufacturer’s printings, that may be useful in decision making.

4. A link to a web document (PDF) for MSDS shall be included with all products.
5. Minimum thickness in mil and vendor name must be displayed on all garbage bag samples to be considered for purchase.
6. All micro fiber products to be Unger brand only. No exceptions.
7. Your company name shall appear on each page of the bid.
