General Information

The Happy Valley School District, established in 1864, is a single school, Basic Aid District with a well established history of community and parent involvement. The Local Control and Accountability Plan (LCAP) fits into this small school culture as stakeholder input is both valued and appreciated. The Board, LCAP Parent Advisory Committee, Parent Club, and Staff routinely have open meeting discussions regarding student achievement, Common Core standards aligned implementation, and alignment of spending priorities. Happy Valley School District serves the students and community with a Mission, Vision and Core Values of continuous improvement, dedication to the arts and music, developing the whole child, and providing students with an academic setting that will ensure success both in secondary and college settings. Happy Valley has a long standing reputation for excellence and has traditionally been one of the top ranked schools in Santa Cruz County, in the top 10% of schools in the state for over the past 10 years, and was in the top 1% of elementary schools in 2023.

With a current enrollment of 110, Happy Valley School District has been awarded the Ocean Guardian grant and is a Green School. The District is K-6 and is comprised of in-district students as well as a small number of inter-district students. Parents fundraise to maintain art, music, garden, and library. The goal of the Parent Club is to raise approximately \$100,000 a year with the ability to put a percentage of the money into the Happy Valley Endowment Fund that is held at the Community Foundation. Started in 1990, the Endowment Fund currently has a balance of over \$1.7 million, which fully funds the instructional aides each year. Although all students benefit from a classroom aide, this model was put in place to intentionally meet the needs of our unduplicated students as well as at risk students. The short term goal was to raise the fund to a \$1 million and that has been reached, with a long term goal of \$3 million, thus lessening the burden on the parents to fundraise at the current level. In March of 2024, the renewal of a parcel tax was passed to "support academic excellence, maintain quality art and music programs, integrate technology into the classrooms, retain high quality teachers and provide local funding that cannot be taken away by the state." In the 2023-24 school year, HVS utilized the parcel tax for teacher stipends, a Tech Design and Science teacher, Tech Support and materials, and curriculum support resources. In 2024 the funds are to be utilized for a teacher raise.

All required metrics outlined by the CDE have been included with the exception of those listed that do not apply to our K-6 District: Advanced Placement scores, Career and Technical Ed (CTE) preparation, Early Assessment Program (EAP) scores, Middle or High School dropout rates, and High School graduation rates. In addition, there are no statistically significant Racial/Ethnic subgroups or Foster Youth attending

school in our District. The LCAP's three goals meet the needs of all students and are primarily focused on unduplicated students, and Special Education students with identified learning targets on their Individualized Educational Plans (IEPs). The three overarching goals include Engagement, Access and Opportunity, and Pupil Achievement.

2023:

Chronic Absenteeism is red. It increased by 6.6% 34.2% chronically absent. We have reconfigured our truancy letters to be very specific and our chronic absenteeism and tardy rate improved in the last year.

The suspension rate is in the yellow, and increased by 0.08%, which was 1 student.

Academic Performance is very high and in the blue, 76 points above the standard in ELA (maintained), and 51.6 points above standard in math.

The Local Indicators were all done correctly and on time. Local indicators were taken to the Board on June 14th and the LCAP was approved on June 21st of 2023. Unfortunately, there was an input error and Happy Valley submitted July 21st as the Board meeting date when the LCAP was approved. Therefore, they all were "not met". When surveying students, students say they are worried that a few kids might be mean, or that they might fall and get hurt on the playground. The parents appreciate that lunch is served daily, and the District is extremely thankful that parents have donated generously to the lunch program so that district monies can pay for other things. Parents are thrilled with the after school activities, and they and their children love the teachers, staff and community. The staff and parents recognize the positive impact of counseling and social emotional learning, and appreciate that Happy Valley focuses on the whole child. There is a concern about funding and the facilities, especially as construction is set over the summer. Continue to maintain strong ELA scores and focus on improving math scores. Students whose scores were not meeting expectations or went down from the year before will receive extra support from the intervention teacher.
