### School Administrator Report: Debbie Lynch

July Report – Paving was completed this week at Pittsburg School. The new lines will accommodate up to 60 vehicles. The gym floor is being sanded and refinished. Work began today. There is an Art camp sponsored by CRAG that Tammy Jeralds is teaching for ages 8-12. 11 students are attending. Open positions at Pittsburg School discussed. She is awaiting an application to arrive for the Elementary position. She has a nomination for AD and Varsity Baseball coach- Josiah Riley. Debbie attended the Principal's Academy in Portsmouth. During this workshop she attended a trauma workshop that focused on DNA (dreams, needs, abilities). They also recommend following a student from kindergarten to graduation to see how their path has changed. She also attended a Social Emotional workshop that discussed therapy dogs in schools, Family Engagement ideas, disciplinary measures such as we don't do this in "our house" to define the school, two minute walkthroughs, etc..

She shared a Wordle that she did the beginning and end of the school year with staff. The two words that stood out at the end of the year were Unique and Memorable.

At the SAU board it will be presented to request the change in the end of quarter dates for January and June to January 17<sup>th</sup> and June 11<sup>th</sup>.

David Covill is interested in teaching Marketing and Design this school year only. He would teach 3 blocks instead of 2 if approved by the board. His contract and benefits would increase as well.

Policy for use of the baseball field at the dam: school will mow, remove trash after use and pay for 3 months of porta potty use.

# Business Manager's Report: Bridget Cross

Area Agreement Timeline Discussion – August 8<sup>th</sup> the State meets to approve the AREA agreement. After this time the districts have 90 days to submit the approved plan by the voters which must occur by ballot at a special meeting. The Clarksville board will cancel their October 14<sup>th</sup> meeting and instead meet on October 15<sup>th</sup> to act on the following: 4:30 Regular Board Meeting, 5pm Public Hearing, 5:30pm Special Meeting

Pre-K Students on School Buses – reviewed the recommendations by NHTSA regarding child restraint systems (8point harness car seat), seatbelts on buses, would require a monitor to assist with buckling and securing, who would pay for the car seats, what happens if the bus is used for another purpose, etc.. It is not recommended that the district provide transportation for Pre-K students.

The school district is required to provide it for special needs students if it's in their IEP. This will be addressed on a case-by-case basis.
