

6. Describe how the school will build capacity for parental involvement including how parents will be encouraged to become equal partners in the education of their children.

To ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, our school:

(a) Shall provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.

Grand Bay Middle School will accomplish this through the Parenting Resource Center in room 405 and the parenting information set out in the main office counter for parents to use and take. The Parenting Resource Center is open from 7:30 a.m. to 2:40 p.m., parents can pick up materials, information, books and use a computer if needed. The center houses materials to assist parents on how they can help their child be successful. Throughout the year, parenting workshops may be held on various topics including, but not limited to: INow student grade access, bullying, internet safety, study skills, and reading/literacy comprehension and math resources.

(b) Shall educate teachers, office personnel, and other school staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school.

Grand Bay Middle School recognizes that parental involvement is a key factor for student academic achievement. Grand Bay Middle School will continue to work with its teachers in understanding the importance of parental and family engagement and that parents are our partners. All staff are expected to welcome parents to the school, as appropriate, and to work with meeting parents' needs for their children. Yearly surveys are used to identify areas of improvement in communicating and working with parents. The parents are offered the opportunity to be on the Parent Advisory Committee, the ACIP Committee and volunteer at the school.

Grand Bay Middle Schools parent and family engagement program is for all parents within the school. A Parent Resource Center is provided for all parents in room 405 and information is displayed in the main office on the counter.

In addition parents are invited to participate at the district level with any programs available including the District Advisory Committee. The program includes ELL and special education students and programs to encourage and support participation in the education of their students.

Information on all school meetings, parent notices, etc., is available for parents in a language they can understand by request. As with the annual review of the Parent and Family Engagement Policy, the Parent Advisory Committee will review activities and make suggestions during this time. The PAC takes recommendations and suggestions and provides feedback for past activities and gives input on future activates. The leadership and staff of Grand Bay Middle School have a strong belief in the importance of parental involvement. Therefore, measures were put in place to offer parent meetings on a flexible schedule. The Statewide Parenting Day will be held on Monday, October 17, 2022. Parents are notified through our school website, school messenger, Facebook page, morning and afternoon announcements, and posted on the school marquee. The following topics will be discussed one on one: being a Title I school, the importance of attendance, opportunities for parent involvement, explain report card grades, schedule parent conferences and have Schoology/Powerschool parent log ins if applicable.

GBMS believes in involving parents in all aspects of the Title I programs. Our process for how all parents have the opportunity for involvement in decision-making is as follows: School personnel and parent leaders who are knowledgeable about Title I, parental involvement, and parents' rights serve as representatives on decision-making committees and as contact persons for parents to answer questions about parental involvement and parents' rights. They keep parents informed of various committee work and receive input from parents for committee decisions. They assist in evaluating the parental involvement plan, and assist in training other parents to be parent leaders. Title I parents are introduced to the parent leaders at the annual meeting of Title I parents at the beginning of the school year. Parents are reminded of involvement activities going on throughout the year through the GBMS web site, Facebook, marquee, and phone messaging.

Funds allocated for parent involvement have been used to purchase parenting booklets, postage, and good notes to mail home. The minimum parent allocation amount for Grand Bay Middle School is \$3914.11.

At parent meetings throughout the fall, Grand Bay Middle School presents information about its Title I programs, the curriculum, forms of academic assessments used and the importance of attendance. Parents learn about goals that have been set in reading and math and our schools 95% monthly attendance. They also learn about how to contact teachers through email, or calling the school to schedule parent teacher conferences. The parents are reminded about how they can participate in decisions related to the education of their child. Documents are provided in Spanish, when needed.

In the spring of 2022 the School-Parent compact was updated by school staff members, our Title I Parent Advisory Committee, and two students. These compacts are now dispersed and collected by the homeroom teacher. The compacts were dispersed, explained, and asked to be signed signifying the parents' commitment to working in partnership with the school and to ensure that their children are successful in school. Teachers will explain the compact to students and obtain student signatures. These compacts will be housed in the homeroom teachers' classroom for use during parent-teacher or student-teacher conferences. A copy is sent home and the final copy is turned into the Title I Facilitator to keep on file. The compact is a working document.
