Dr. Lori Stanfield moved to accept the Personnel Report as presented and detailed above.

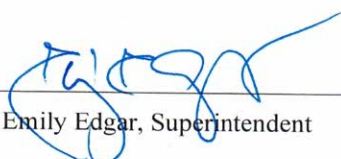
Dr. Katie Fuller seconded the motion, which passed with a unanimous vote.
