

# Richey Public Schools Discipline Matrix

Richey Public Schools uses PBIS to reinforce positive behaviors; however, the following guidelines will be implemented for behavior violations. The school and the district maintain the right to modify any consequence based on the nature, severity, and circumstances of specific incidents. Teachers will notify parent/guardians when discipline occurs in the classroom. Superintendent will notify parent/guardians when discipline issues are dealt with in the administrative office.
