School Responsibilities

The Continuous Learning Center will:

- Facilitate positive communication between administrators, teachers, parents, and students

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:

- Conferences can be scheduled through the front office, teachers, and counselors.
- Conferences will be held during the teacher's planning period, before school, or after school
- Teachers may contact parents for conferences as needed

3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:

- Progress reports will be sent by the 5th week of each quarter
- Report cards will be issued at the end of each quarter
- Grades are available through Schoology throughout the school year

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

- Parents may contact faculty and staff by calling the main office at 221-2122, note/letter, email, or through the school's website

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

- Parents are encouraged to participate on the Parent Advisory Committee
- Parents may observe classroom activities with prior administrator approval
- All parents must report to the front office to request a visitor's badge

6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.

- Parents may contact the school staff via phone, email, or in person. Responses will be made within 24-48 hours in a language understandable
- If a different language is requested, MCPSS ESL Office will provide the needed documents or an interpreter to assist

Parent Responsibilities


We, as parents, will support our children's learning in the following ways:
