The Franklin County Community School Corporation will accept Snow Plowing and Ice Removal proposals. All proposals should include snow removal from specified areas (driveways, parking lots, bus turnarounds, bus transfers, and sidewalks); relocation of snow as needed; and application of ice melt. Services will commence with the first measurable snowfall or ice event of the 2024-2025 season. **As we understand, the purchase of "salt" may provide cost savings when purchased in bulk; the board will entertain both a one (1) year proposal, as well as a three (3) year proposal.**

Contractors may submit proposals for the following sites:

Site 1: Includes Brookville Elementary School, Franklin Middle School, Franklin County High School, Wildcat Lane, Franklin County Transportation Facility, and the Franklin County Community School Corporation Administration Building

Site 2: Laurel School

Site 3: Mt. Carmel School

Contractors may choose to submit a proposal for a single site or for all sites.

Contractors are responsible for:

- 1) All equipment used on site. Must provide a list of equipment to be used.
- 2) Proof of insurance.
- 3) Criminal Background Checks for anyone working on school grounds.

- 4) Response time of one hour after contact is made by the owner.
- 5) Purchase and storage of ice melt.
- 6) Removal of any snowfall accumulation 1" or more on designated areas: parking lots, driveways, sidewalks, and bus transfer sites (Metamora Opry Barn and Lakeview Gas lot)
- 7) Application of ice melt on designated areas: parking lots, driveways, and sidewalks.
- 8) Monitoring of "refreeze" and reapplication of ice melt and/or additional clearing if necessary.
- 9) Monitoring of "drifting" and reapplication of ice melt and/or additional clearing if necessary.
- 10) Relocation of snow to designated areas.

Upon the submission of claims, contractors can expect to be paid on the second Tuesday of the month.
