Parental Involvement Policy

Louisville High School is committed to educating the children in our community. We feel that parent involvement is essential to ensuring that our students are successful in school. We pledge to maintain a good line of communication from school to home and our goal is to provide ample opportunities for parental involvement throughout each school year.

A. POLICY INVOLVEMENT

Formal training and workshops scheduled throughout the year are guided by parent input and survey data and vary in date and time. Due to the hectic and varying schedules of our school family, efforts will be made to provide training opportunities to parents via links on our school website making information accessible twenty-four hours a day. Parents will be invited to participate in a parent-teacher conference at least twice a year to discuss their child's progress. Teachers may receive parents in the morning, during the school day, and/or after school to accommodate as many reciprocating parents as possible.

3. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including planning, review, and improvement of the school parental involvement policy.

Our school annually invites parents to participate in review and revision meetings to examine and discuss our School Action Plan and Parent Involvement Policy. The school's Title I Committee consisting of parents, community members, and school staff consistently reviews school policy in an organized, ongoing, and timely way.

benchmark results, Twitter, Facebook, Winston County Journal coverage, WLSM Radio Station coverage, etc. to solicit parent participation and deliver important information in hopes of creating a productive dialogue between home and school concerning improved student achievement.

B. SHARED RESPONSIBILITIES FOR HIGH-STUDENT ACADEMIC ACHIEVEMENT

As a component of the school-level parental involvement policy, each school shall jointly develop with parents for all children served under this part a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.

The education of a student is not only the responsibility of the teacher but also of the parent and the child. 3. Faculty and staff members will be cognizant of educational research on parent involvement. Parental input will be solicited throughout the year in meetings, through surveys, and during one-on-one conferences. Information derived will be utilized by the school's Leadership Team to strengthen the tie between school and home to increase student achievement.

LHS offers Active Parent so that parents can monitor their child's academic progress. To meet the needs of our diverse group of parents, our Title I coordinator conducts monthly parent and family engagement activities such as Coffee with the Counselors and Parent University programs. The Title I committee meets throughout the school year to review the School Wide Plan, get input on how to spend 1% of Title I funds for parent and family engagement, and to revise the Parent and Family Engagement Plan. Athletic coaches also host Meet the Wildcats before their seasons begin and invite parents to come meet their players while offering educational information to parents that are in attendance
