1.02 STATEMENT OF PURPOSE:

- A. This Request for Proposals is issued by Christian County Public Schools to solicit proposals from qualified individuals and organizations ("Offerors") to furnish furniture, equipment, and additional items through Procurement State Master Agreements and/or Procurement Cooperatives for the new Christian County High School and to provide additional services related to those items including assembly and installation of said items, providing education and training to Owner's employees related to the use of said items, and removal of any trash or other debris resulting from the items being provided.
- B. Christian County Public Schools is utilizing competitive negotiation in accordance with KRS 45A.085 because sealed bidding is not practicable due to the nature of items and services needed.

1.03 LEGAL REQUIREMENTS:

- A. Offerors are advised that any contract resulting from this RFP must comply with all applicable provisions of KRS Chapter 45A (Kentucky Model Procurement Code) and other statutes and policies noted in this RFP. Christian County Public Schools' policies and procedures for procurement are fully incorporated by reference into this RFP. A copy of these policies may be obtained from the office of Christian County Public Schools upon request at a cost not to exceed the cost of reproduction.

1.04 INSTRUCTIONS TO OFFERORS: Refer to Document 00100 - Instructions to Offerors.

Upon review of the evaluations and scores, Owner shall notify Offerors of the highest evaluated Proposals to schedule interviews with said Offerors. Based on the evaluations and interviews, Owner shall conduct negotiations and after successful negotiations are concluded, Owner shall award a Contract in accordance with the award methodology stated in the RFP

1.06 REJECTION

- A. The Owner reserves the right to reject any and all Proposals, and to waive any irregularities or informalities.

INSTRUCTIONS TO OFFERORS

1.01 BID SECURITY

- A. Bid security will not be required.

1.02 PERFORMANCE BOND AND LABOR AND MATERIAL PAYMENT BOND

- A. A Performance Bond will not be required.

1.03 PROPOSAL DOCUMENTS

- A. In any document the word "Contractor" or "Offeror" refers to the Offeror; the word "Owner" refers to Christian County Public Schools.
- B. Complete Sets:
 - 1. Complete sets of Proposal Documents shall be used in preparing proposals.
 - 2. Neither the Owner nor the Architect assumes any responsibility for errors or misinterpretations resulting from the use of incomplete sets of Proposal Documents.
- C. The Owner or Architect in making copies of the Proposal Documents available on the above terms, does so only for the purpose of obtaining proposals on the Work and does not confer a license or grant for any other use.
- D. Contractors:
 - 1. Approved Offerors will receive one (1) set of Drawings and Project Manual from Architect, to be distributed electronically.

1.04 EXAMINATION

- A. Offerors shall carefully examine the Proposal Documents and the Site to familiarize themselves with existing local conditions under which the Work is to be performed.
- B. Offerors shall carefully examine the Proposal Documents to verify that they agree with the Table of Contents in the Project Manual, the Index of Drawings Sheet on the Drawings, and the Cover Page of all Addenda. Offerors shall be responsible for obtaining any pages or sheets which may have been inadvertently left out during the printing process. Offerors shall be responsible for reviewing the furniture drawings to verify quantities suggested (if provided) on Hafer Specification Sheets.
- C. Extra payments will not be authorized for work that could have been foreseen by careful examination of the Site. Submission of a proposal shall constitute acceptance, by the Offeror, of existing Site conditions as a part of the requirements for this work.

1.05 INTERPRETATION OF PROPOSAL DOCUMENTS

- A. Offerors shall promptly notify the Architect of any ambiguity, inconsistency, or error which they may discover upon examination of the Proposal Documents or of the Site and local conditions.
- B. All questions regarding clarification or interpretation of Proposal Documents are to be directed to the office of the Architect:

- C. Submit all questions in writing by emailing Rebecca Brady at the email address above. Replies to any one Offeror's question will be issued to ALL Offerors in an addendum.
- D. Make requests for interpretations as early as possible so as to allow adequate time to prepare and issue Addenda. Questions must be submitted no later than November 12, 2025.
- E. All Contractors shall check with the Architect within 24 hours prior to the Proposal Due Date to secure all Addenda. The Architect and Owner will not be responsible for oral clarification.

1.06 BASIS OF PROPOSALS

- A. Proposals shall be on a lump sum basis and shall include all costs for this Project as described and indicated by the Proposal Documents. Basis for proposals shall be on manufacturers, materials, processes, products, persons or organizations, etc., indicated in the Proposal Documents.
- B. Proposals shall include all Unit Price costs as indicated by the Proposal Documents and proposal form and include specification report forms with unit costs and extended costs recorded on report form sheets.

1.07 ALTERNATES

- A. Voluntary alternates will be considered for all items where indicated on the proposal form.
- B. Submit all alternate requests in writing (email) by end of day October 30, 2025 to the following emails: rbrady@haferdesing.com and jason.wilson@christian.kyschools.us. Include cutsheets and pertinent product information for evaluation.
- C. All Alternate items/materials must meet or exceed quality, warranty, and attributes of original specification. Lower quality items/materials will not be accepted. Determination of equivalence is left to the discretion of the Owner and/or Interior Designer.
- D. The Owner may, at their option, elect to proceed with any or all Alternates as set forth in the proposal requirements.
- E. Amount shown on proposal form for each Alternate shall include profit, insurance, contingencies, taxes, and other costs incidental to performance under such Alternative.
- F. Amount shown on proposal form for each Alternate shall include the making of all changes and the installation of all materials and equipment necessary to the accomplishment of the Alternate requirements.

1.08 PROPOSAL COST

- A. Authorized work, done in addition to that indicated by the Proposal Documents, will be paid for as an extra according to the Furniture Spreadsheet. Costs of authorized omissions of work from that indicated by the Proposal Documents will be deducted from the Contract Sum according to the Furniture Spreadsheet.

- B. Amounts shown on Furniture Spreadsheet shall be total compensation; labor, materials, fees, profit, overhead, insurance, and other expenses to be added or deducted from the Contract Sum. However, Installation shall appear as separate costs on line items on the Furniture Spreadsheet.
- C. An electronic copy of the Furniture Spreadsheet is included with the proposal form and shall be a part of the Agreement.
- D. Offeror agrees to maintain discounting structure on all products specified in this package, contract price, for an additional 3 months after Owner occupancy of each phase of the building/project. In addition, Offeror agrees to maintain the % range of freight and installation of original purchase order agreements for said period.

1.09 PROPOSALS

- A. Proposals shall be made on unaltered Furniture Spreadsheet furnished by the Architect. No oral, telephonic, or personal Proposals will be considered. All blank spaces shall be properly filled in type written.
- B. Any alteration or erasure to information entered in the blank spaces must be initiated by the signer of the Proposal. Offeror shall make no additional stipulations on the Furniture Spreadsheet nor qualify their proposal in any other manner. Each Proposal must provide every piece of furniture listed on the Furniture Spreadsheet.
- C. Proposal Format (for both loose and systems): Each Proposal MUST include the following:
 1. Solicitation Response Cover Page (Section 01750)
 2. Required Affidavit for Bidders or Offerors for Campaign Finance Disclosures (Section 01760)
 3. Required Affidavit for Bidders, Offerors, and Contractors Claiming Resident Bidder Status (Section 01770)
 4. Offeror's Experience and References
 5. Detailed written specifications showing that product(s) meet/match criteria of base standard specified by the Interior Designer. Each component, part number, and designated finish must be CLEARLY described in a manner easily recognizable as to allow for review and comparison. The Offeror standard proposal format is acceptable, submitted as a pdf file.
- D. Failure to submit a Proposal in the form requested, or the inclusion of conditions, limitations or provisions distorting the intent of the Proposal Documents, will render the Proposal irregular and subject to rejection.
- E. To ensure pricing can conform to the project timeline, pricing will be qualified as follows. The initial price on the bid form will be denoted with the length of time the price will be held, but no less than 90 days following the anticipated construction completion date. The discounting structure will be listed as well as the current list price. Discounting structures will be held until project completion and price increases will be verified by submitting new publicly available pricing guides.

1.10 SUBMITTAL OF PROPOSALS

- A. Submit Proposals electronically to Christian County Public Schools, ATTENTION: Dr. Jason Wilson, jason.wilson@christian.kyschools.us, and provide one additional copy of the Proposal to Hafer, ATTENTION: Mrs. Rebecca Brady, rbrady@haferdesign.com. Proposals shall be addressed to the Owner and identified with the Christian County High School Furniture and the name and address of the Offeror.

- B. If the Proposal is sent by mail the sealed envelope shall be enclosed in a separate mailing envelope with the notation "PROPOSAL ENCLOSED" on the face thereof.

1.11 MODIFICATION OR WITHDRAWAL OF PROPOSAL

- A. A Proposal may not be modified, withdrawn, or canceled by the Offeror during the stipulated time period following the time and date designated for the receipt of Proposals, unless the award of Contract has been delayed more than sixty (60) days.
- B. Prior to the time and date designated for receipt of Proposals, Proposals submitted early may be modified or withdrawn only by notice to the party receiving Proposals at the place and prior to the time designated for receipt of Proposals.
- C. Modification of Proposals shall be in writing over the signature of the Offeror or be by facsimile; if by facsimile, written confirmation over the signature of Offeror must have been mailed and postmarked on or before the date and time set for receipt of Proposals; it shall be so worded as not to reveal the amount of the original Proposal.
- D. Withdrawn Proposals may be resubmitted up to the time designated for the receipt of Proposals provided that they are then fully in conformance with these instructions to Offerors.

1.12 CONSIDERATION OF PROPOSALS

- A. Properly identified Proposals received on time will be opened privately and winning Offerors will be informed as to the Successful Offeror within a reasonable time.
- B. All proposals will be evaluated by Owner and Architect, with each factor scored individually and then totaled to determine final ranking. The maximum possible score is 100 points. The table below sets forth the categories to be used in evaluation:

Discussions and best final offers, if used, will be incorporated into final scoring. Award will be made to the Offeror whose proposal is most advantageous to Owner, considering all evaluation factors and the reciprocal preference requirements.

- C. The Owner shall have the right to reject any or all Proposals and in particular to reject a Proposal not accompanied by data required by the Proposal Documents or a Proposal in any way incomplete or irregular.
- D. The Owner shall have the right to waive any informality or irregularity in any Proposal received.
- E. If the Owner accepts any Alternates, they shall have the right to accept them in any order or combination.
- F. It is the intent of the Owner to award a contract to the lowest responsive and responsible Offeror provided the Proposal has been submitted in accordance with the requirements of the Bidding Documents, is judged to be reasonable, and does not exceed the funds available. The Owner reserves the right to award the Contract in part or whole to the Contractor that will best serve their requirements regardless of Proposal amount. The Owner reserves the right to award the contract to one Offeror or to divide the package, thus awarding multiple contracts to multiple Offerors based on these requirements.
- G. Award of Contract may include full consideration of completion time, unit prices and Alternates. Owner may accept or reject any or all Alternates. Owner may select any Offeror regardless of base Proposal amount.

1.13 OFFERORS ACCESS TO PREMISES

- A. Once the Proposal is awarded, the dealer(s) selected can view the premises. Contact Jason Wilson at least 24 hours in advance. Offerors must be escorted through the premises; no exceptions.
- B. Offerors shall cooperate with the other contractors who may concurrently be working on the premises.

1.01 AGREEMENT FORM

- A. The “Standard Form of Agreement Between Owner and Contractor for Furniture, Furnishings and Equipment”, American Institute of Architects Document A151, 2019 Edition, will be made available upon request from the Owner as the form used as a Contract for this Project.
- A. A copy of the Document is included in this Project Manual and shall apply to each and every Section of the Work as though written in full therein.
- A. Additional copies of the Standard AIA Document may be purchased from the American Institute of Architects, 1735 New York Avenue, N. W., Washington, D.C. 20006.
- A. Where conflict exists, the Owner’s General Terms and Conditions (if supplied) or most restrictive terms stated in this document shall govern.

A.02 GENERAL CONDITIONS

- A. The General Conditions of this Contract, refers to this front end.

DOCUMENT 00814

SALES TAX

- 1.01 State and municipal sales tax shall be included in Proposals submitted for personal property required in this project to the extent state and municipal taxes are required by law. The title to this facility is in the name of Owner. Orders for all tangible personal property will be placed by the Contractor or Subcontractor as the agent of the Owner and the title will not pass from vendor directly to the Contractor.
- 1.02 All tangible personal property and materials are being purchased by the Contractor or their Subcontractor for and on behalf of the Owner and said materials and property are to be invoiced by the vendor to the Owner, and upon delivery of materials or property, proper claims are to be submitted by the vendor to the Contractor by invoice to the Owner. All contracts with Subcontractors will include a provision identical to this paragraph.
- 1.03 All such tangible personal property sold or leased direct to the Owner by the vendor is not exempt from State and Municipal sales tax.

SPECIAL CONDITIONS

1.02 INSTALLATION SCHEDULE

- A. The Contractor shall have access to the building on or about May 4, 2026 unless otherwise stated in the Agreement. The Contractor's manufacturing processes and deliveries of all product specified within will be timed to meet the requirements of this building's installation dates, but later than May 18, 2026.
- B. The dealer will be notified 30 days prior to start of furniture installation. Dealer will have 8 weeks to complete installation. Include night and weekend work in Proposal price to complete installation in two weeks.
- D. Do not install any furnishings until space is enclosed and weatherproof, wet-work in space is completed and nominally dry, work above ceilings is complete, ambient temperature and humidity conditions are and will be continuously maintained at values near those indicated for final occupancy, and Project Manager, Architect, and Owner have approved installation to commence.
- E. The Contractor is required to attend a "Pre-Installation" Meeting prior to furniture installation, date(s) and frequency to be established by Architect and/or Owner, for the purpose of:
 - 1. Review progress of other work and preparation for installation, including possible conflicts, time schedules, space and access limitations, and acceptability of substrates.
 - 2. Review instruction on scheduling dock access, and use of elevators (if applicable).
 - 3. All parties present shall state their authority and identify the parties with the authority to schedule and administer their branch of the work throughout the installation period. All installation management supervisors from dealership(s) are required to attend to ensure requirements are passed along to all team members.
 - 4. At Owner's discretion, pre-install meeting could be limited to direct phone and email contact with Contractor. **Contractor is responsible for contacting Architect and/or Owner to ascertain preference of Owner.**
- F. Refer to Section 01710, CLEANING, PART 3 EXECUTION for additional requirements for installation, management of waste, etc.
- G. **If schedule changes Contractor will provide temporary warehousing at no charge to Owner for up to 1 months after anticipated install date for each phase. If the project is delayed longer than 1 month the vendor will continue to provide temporary warehousing on at the daily rate stipulated on the Proposal form.**

SECTION 01010

SCOPE OF WORK

1.01 GENERAL

- A. The Work of this Contract comprises the furnishing of furniture, equipment, and additional items through Procurement State Master Agreements and/or Procurement Cooperatives for the new Christian County High School and to provide additional services related to those items including assembly and installation of said items, providing education and training to Owner's employees related to the use of said items, and removal of any trash or other debris resulting from the items being provided..
- B. Work labeled "Not In Contract" (N.I.C.) or "Owner Furnished Owner Installed" (O.F.O.I.) will be furnished and installed under separate contract.

1.02 ASSIGNED CONTRACTS

- A. Relations and responsibilities between Contractor and assigned subcontractors shall be identical to that between Contractor and sub-contractors they have selected.
- B. Assigned subcontractors shall purchase and maintain liability insurance as will protect them from claims, for not less than the limits of liability which Contractor is required to provide to Owner.

1.04 CONTRACTOR'S USE OF PREMISES

- A. Confine activities to uses permitted and restricted by law, ordinances, permits, building regulations, tenant lease, and the Contract Documents or instructed by Construction Manager.
- B. Limit use of premises to the Work, Storage, Loading, and Parking and to allow the following:
 - 1. Do not block or interfere with vehicular or pedestrian access to building or any portion thereof required for conducting Owner's normal operations.
 - 2. Work conducted by Owner's normal operations.
 - 3. Perform the Work with a minimum of disruption by noise, odors, dust, or other disruptive causes to Owner's normal operation.
- C. Do not unreasonably encumber the site with materials or equipment.
- D. Do not load the structure with weight that will endanger the structure.
- E. Assume full responsibility for the protection and safekeeping of stored products under this Contract on premises.
- F. Move any stored Products, under Contractor's control, which interfere with operations of the Owner or separate contractor.
- G. Obtain and pay for the use of additional storage or work areas needed for operations.

ALTERNATES

1.01 SUMMARY

- A. The Owner may, at their option, elect to proceed with any or all Alternates as set forth in the Proposal Requirements. Specified products must be bid unless dealer is prohibited by manufacturer contracts and pricing on specified products must be listed PRIOR to listing any ALTERNATES. If pricing on specified products is not included and you SUBSTITUTE rather than provide ALTERNATES, those Coded items will be voided from Proposal process.
- B. Amount shown on Proposal Form for each Alternate shall include profit, insurance, contingencies, and other costs incidental to performance under such Alternative. Amounts for alternates are not to be included in lump sum total for base proposal.
- C. Amount shown on Proposal Form for each Alternate shall include the making of all changes and the installation of all materials and equipment necessary to the accomplishment of the Alternate requirements.

SECTION 01600

MATERIAL AND EQUIPMENT

1.01 MANUFACTURER'S INSTRUCTIONS

- A. Contract Documents require that installation of work shall comply with manufacturer's printed instructions, obtain, and distribute copies of such instructions to parties involved in the installation, including two copies to the Architect and Owner.
 - 1. Maintain one set of complete instructions at the job site during installation and until completion.
 - 2. Contractor shall provide ALL installers with a clearly labeled and coded installation plan. The installer must arrive onsite with this plan to place contract items accordingly. Installers will be required to return to project site at no additional charge to correct improper installation/placement of contract items.
- B. Handle, install, connect, clean, condition and adjust products in strict accord with such instructions and in conformity with specified requirements.
 - 1. Should job conditions or specified requirements conflict with manufacturer's instructions, consult with Architect for further instructions.
 - 2. Furniture supplier must as part of their proposal number contract with a certified electrician to properly connect all furniture requiring power and data connection.
 - 3. Do not proceed with work without clear instructions.
- C. Perform work in accord with manufacturer's instructions. Do not omit any preparatory step or installation procedure unless specifically modified or exempted by Contract Documents.

1.02 DELIVERY OF MATERIALS

- A. ALL deliveries MUST be scheduled and coordinated with Owner's Representative at a minimum of seven (7) working days prior to date of requested install. Delivery requests made with less than seven (7) days' notice will not be accepted unless special arrangements are accepted by the Owner's Representative. Do not contact Architect or Owner to make these arrangements.
- B. Contractor to deliver furniture only when site is ready for installation and shall provide warehousing for incoming furniture as required.
- C. Arrange delivery of furniture to follow project phasing. Refer to the phasing schedule included with the Proposal documents. Dealers will receive a 30 days notice prior to installation. Each phase will have two weeks for installation of furniture that will commence at the end of the 30 days' notice. All installation must be complete in this window. Night and weekend work required to complete this Proposal should be included in Proposal numbers.
- D. Deliver and handle goods according to manufacturer's recommendations, using means and methods that will prevent damage, deterioration, and loss.
- E. All materials shall be delivered in their original, unopened containers which shall bear the seal, trademark or hallmark of the respective associations or councils and the identification label of the manufacturer.

- F. The Contractor shall inspect all materials upon their arrival at the job and see that they conform to the requirements of these Specifications and prevent the unloading of unsatisfactory material or promptly remove same from the premises without waiting instruction from the Architect to do so.
- G. Schedule delivery to eliminate storage at the Project Site, and to prevent the overcrowding of construction spaces. Coordinate delivery for items that are flammable, hazardous, easily damage, or sensitive to deterioration or theft to ensure minimum holding time.
- H. Provide for continuity of any phase of work. Sufficient quantities for completion of a phase shall be on the Project Site before that phase is started.
- I. Provide equipment and personnel to handle products by methods to prevent soiling or damage.
- J. Due to construction a dock will not be available onsite to receive deliveries. Delivery by tractor trailer must be arranged with the owner in advance. All material will be offloaded without the use of a dock.
- K. Notify the Architect and Owner's Representative immediately of damaged or incomplete shipments, along with schedule for replacement/completion.
- L. All delivered items shall be cleared from the dock and stored properly at the end of each day.
- M. Contractor is financially liable and responsible for any damage to building or contents caused by any parties under their contract or supervision, during any period of furniture installation process. Any such damage should be documented and reported to Architect as soon as possible

1.03 STORAGE AND PROTECTION

- A. Store Products at Project Site according to manufacturer's recommendations with seals and labels intact and legible, and in a manner that will facilitate inspection and measurement of quantity or counting of units. Store Products using means and methods that will prevent damage, deterioration, and theft or other loss.
 - 1. Store products subject to damage by the elements in weathertight enclosures.
 - 2. Maintain temperature and humidity within the ranges required by manufacturer's instructions.
- B. After installation provide substantial coverings as necessary to protect installed Products from damage from traffic and subsequent construction operations. Remove when no longer needed.

1.04 COORDINATION

- A. Contractor is responsible for field verification of room dimensions and building measurements to ensure appropriate conditions exist to meet specifications and ensure proper installation. Verifications must be documented.
- B. Coordinate connection of building electrical power to systems' furniture and table power connections with Architect/Owner/Construction Manager, in conjunction with Electrical Contractor, certified in the State of WV.
 - 1. Contractor is responsible for field verification of ALL electrical and data receptacle placement to ensure proper coordination with furniture installation. Locations must be accurately documented.
 - 2. Field Verifications should be performed PRIOR to placement of furniture order if possible. Field Verifications should be performed PRIOR to doing work or placing material orders

dependent for proper size or installation on coordination with building conditions. Any discrepancies or issues discovered between Contract Documents and existing conditions must be brought to the attention of the Interior Designer and Architect **via email** as soon as possible to coordinate a resolution.

3. Contractor shall be held responsible for the remediation of any incorrect ordered items.

1.05 SUBSTANTIAL COMPLETION

A. **Contractor to perform own, separate punch list inspection after completing installation prior to Interior Designer completing a separate Substantial Completion Punch List.**

Contractor shall submit own written Punch List document (certification and list of items to be completed and/or corrected) to Interior Designer for review and comparison.

- B. It is the responsibility of the Contractor to ensure every product is installed properly, undamaged, and in proper working order. Any deviation from this should be documented, as well as the amount of time necessary for Contractor to correct these issues.

- C. Preliminary Procedures: Before requesting inspection for certification of Substantial Completion, complete the following. List exception in the request.

1. In the Application for Payment that coincides with, or first follows, the date Substantial Completion is claimed, show 100 percent completion for the portion of Work claimed as substantially complete.
 - a. Include supporting documentation for completion as indicated in these Contract Documents and a statement showing an accounting of changes to the Contract Sum.
 - b. If 100 percent completion cannot be shown, include a list of incomplete items, and reasons the Work is not complete
2. Advise the Owner of pending insurance changeover requirements.
3. Submit specific warranties, maintenance agreements, final certifications, and similar documents.
4. Obtain and submit releases enabling the Owner unrestricted use of the Work and access to services and utilities.
5. Submit final project photographs, damage or settlement surveys, and similar final record information.
6. Refer to Section 01710 CLEANING for requirements.
7. Refer to Section 01730 OPERATING AND MAINTENANCE DATA for requirements.
8. Touch up and otherwise repair and restore marred, exposed finishes.

- D. Review Procedures: Interior Designer will determine whether or not Project is ready for Substantial Completion inspection and advise the Contractor/ of unfulfilled requirements:

1. If not ready, Interior Designer will state general areas which require completion and/or correction prior to inspection.
2. If ready, Interior Designer will commence inspection within ten (10) days of receipt of Contractor certification and list as noted above.

- a. The review will be conducted by Interior Designer. Once the Interior Designer has completed review an additional review may be required at request of Interior Designer. This review may include the designated Owner Representative and Contractor Representative. Appropriate participants will be determined by Interior Designer.

1.06 FINAL ACCEPTANCE

- A. Final Review: Request final review once all conditions required have been satisfied and corrected.
 - 1. The Interior Designer/Owner will re-inspect the Work on receipt of notice that the Work, including punch list items from earlier inspections, has been completed, except for items for which completion has been delayed because of circumstances acceptable to the Interior Designer.
 - 2. Upon completion of re-inspection, the Interior Designer/Owner will notify Contractor of final acceptance, OR advise about the Work that is still incomplete OR about obligations that have not been fulfilled but are required for Final Acceptance.
 - 3. If necessary, re-inspection will be repeated.
 - 4. Final acceptance is assumed as white glove fully functional product with all electrical and building connections made. Including anchoring of units to wall where required by code.

CLEANING

PART 1 GENERAL

1.01 DESCRIPTION

- A. Execute cleaning, during progress of the Work, and at completion of the Work, as required by General Conditions.

1.02 DISPOSAL REQUIREMENTS

- A. Conduct cleaning and disposal operations to comply with codes, ordinances, regulations, and anti-pollution laws.
- B. Remove all refuse including packing material, cartons, and packaging material related to installation and delivery from the site, without using building contractor's or owner's trash containers.

PART 2 PRODUCTS

2.01 MATERIALS

- A. Use only those cleaning materials which will not create hazards to health or property, and which will not damage surfaces.
- B. Use only those cleaning materials and methods recommended by manufacturer of the surface material to be cleaned.
- C. Use cleaning materials only on surfaces recommended by cleaning material manufacturer.

PART 3 EXECUTION

3.01 DURING INSTALLATION

- A. Contractor at all times shall keep the premises free from accumulation of waste materials or rubbish caused by their operations or their subcontractor's operations. Oversee cleaning and ensure that building and grounds are maintained free from accumulations of waste materials and rubbish.
- B. At reasonable intervals during progress of work, clean up site, building and access, and dispose of waste materials, rubbish, and debris. Legally dispose of such waste materials at public or private dumping areas off the Owner's property.

3.03 FINAL CLEANING

- A. At completion of installation just prior to acceptance or occupancy conduct a final inspection of all furnishings. Perform final cleaning and maintain cleaning until building, or portion thereof, is accepted by Owner.
- B. Cleaning by each Vendor: Employ experienced workers or professional cleaners for final cleaning. Clean surfaces or units to the condition expected in a normal, commercial building cleaning and maintenance program. Comply with manufacturer's written instructions.
 - 1. Complete the following cleaning operations:
 - a. Remove labels that are not permanent.
 - b. Clean mirrors and glass. Remove glazing compound. Replace clipped and broken glass.
 - c. Clean exposed hard-surfaced finishes to a dust free-condition, free of stains, films, and similar foreign substances.
 - d. Vacuum carpeted and upholstered surfaces thoroughly.
 - e. Remove temporary protection.
- C. Remove all waste materials and rubbish from and about the Project as well as all tools, construction equipment, machinery, and surplus materials.

PART 1 GENERAL

1.01 GENERAL

- A. Compile Manufacturer's Directions and Manuals, Product Data and related information appropriate for Owner's maintenance and operation of products furnished under the Contract.

- B. Operating and maintenance manual shall constitute the basis of instruction.
- C. Review contents of manual with personnel in full detail to explain all aspects of operations and maintenance.

- D. Any State Governed Agencies Required.

1.03 QUALITY ASSURANCE

- A. Manufacturer Qualifications:
 - 1. Manufacturer shall submit evidence of having not less than five (5) years successful production of similar product.
- B. Subcontractor Qualifications: Subcontractor shall submit evidence of skill and not less than five (5) years specialized experience with similar product.
