Superintendent's Comments:

Mark Henson talked about the STEAM program. West Fannin Elementary School is looking at agriculture. They have worked with the cannery, Mercier Orchards, and the greenhouse in McCaysville. Mr. Henson commended Barbara Davenport on being such an asset in the system. She works in the cannery, substitutes, and drove a school bus for years; she does a very good job with the children. Mr. Henson shared the 92.3% graduation rate for Fannin County for last year. That is the highest rate the school system has ever had. Mr. Henson stated he is very

proud of that rate but still striving for 100%. Mr. Henson announced there will be an "Eggs and Issues" meeting at the Swim and Tennis club on Wednesday from 8:30-10:30. Following that will be a Transportation / DOT meeting at the PAC from 10:00-2:30. Mr. Henson stated he would like to get the SPLOST list finalized at the December meeting. He expressed how extremely important SPLOST is to the system and how it benefits the taxpayers. It lowered the millage one whole mill. Mr. Henson read the high school's inspirational note that is put out on Fridays. The note had comments from new teachers to the system regarding the Veterans' Day program. One teacher felt like they were watching a movie, and another was amazed at how you could put an entire student body in an assembly and have them behave so well. Mr. Henson said that we have good kids, and they understand the value of the veterans; he appreciates this community for emphasizing that to our kids.

Board Members' Comments:

Steve Stanley thanked Mrs. Susan Holloway and her staff for the hard work they do each day. Mr. Stanley stated he was pleased with the way the students honor the veterans. He expressed how proud he was of the 92.3% graduation rate and commended the faculty for doing a wonderful job.

Sandra Mercier commended the vision statement with the goal being 100% graduation rate. Mrs. Mercier stated kudos and accolades to every employee in the system for being a part of ensuring all the students in the school system graduate. Mrs. Mercier stated she appreciated everybody's efforts. Mrs. Mercier wished everyone a "Happy Turkey Day!"

Lewis DeWeese stated he keeps hearing "kids first." Mr. DeWeese stated he believes that's what the system does, and that's the heart of it. Mr. DeWeese wished everyone a happy and a safe Thanksgiving.

Terry Bramlett thanked the Board, staff, administrators and so many others that offered their prayers and support last week during the loss of his mother. Mr. Bramlett spoke of life's ups and downs and how impressive it is to be surrounded by such kind people. Mr. Bramlett congratulated Mrs. Holloway on her incredible audit report. He commended Mrs. Holloway on her attention to detail, her meticulous oversight of the financial affairs, and how blessed we are to have her. Mr. Bramlett stated the citizens of Fannin County have so much to be proud of when they consider the accomplishments in our district. Mr. Bramlett stated he considered it an honor to be a part of this organization.

Bobby Bearden thanked everyone for being at the meeting. He stated he was privileged to go to Blue Ridge Elementary School's Veterans' Day program, and how nice it was to have the students present the program. Mr. Bearden commended them on an excellent job. Mr. Bearden hopes to have the "Huey" helicopter updated in less than six months. He is waiting on good weather to be able to apply the paint. Mr. Bearden feels the Veterans' Park at Fannin County Middle School is in an excellent thing to have, and it's in an excellent location. Mr. Bearden wished everyone a Happy Thanksgiving and said he was happy to be a part of the Board.
