Collection of personal information:

Information collected directly from you: We may collect personal information directly from you, for example through an email or in person.

Personal information we collect directly from you may include: first and last name, address, email address, and cell phone number.

Use of Personal information:

We use information collected directly from you to provide you with emergency notifications as part of our school emergency response plan.

Disclosure of personal information:

We may use third-party service providers to assist us with providing setup and maintenance of our emergency notification system.

We use Mitel Revolution for our text message communications. This system is maintained by Ipro [Teamipro.com] and Business Communications Specialists [bcsip.com]

Your personal information will not be shared with any other third parties for any marketing or promotional purposes.

We may also share your personal information if necessary to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.

If you wish to stop receiving text messages from us, please contact SLSD IT team or SLSD's Safety Officer.
