- Preliminary Budget Analysis
 - Based on projected costs at this point in time, we are projecting a deficit of \$ 42,000 for FY 2022. Current balance in the Tuition Expendable Trust Fund is \$ 82,561.83 of which \$ 40,000 will be applied to the FY 21-22 budget per vote in March.
- Discussed the year end financial statement. The projected balance on hand is \$ 5,275.08
 - This balance is based on withdrawing from the Tuition Expendable Trust in May to cover unanticipated Tuition Expenses. The board has an option to return a portion to the Trust Fund if you chose otherwise, it would reduce next year's taxes.

<u>E. Blanchard / H. Mitchell</u>: To return \$ 3,500 to the Tuition Trust Fund as unanticipated VOTE: MOTION CARRIES

- Parent request for Preschool Transportation
 - Discussed preschool transportation options;
 - WW Berry is willing to transport, this year, if they have the PK seating available (specific seat requirements), the child can ride unassisted, parents must buckle them into the seat and a Pittsburg staff would have to get them off the bus (unbuckle) and the board votes to allow it. This would be for an existing bus stop or an acceptable bus stop on the existing route.
 - Discussed with our insurance company. Safety measures need to be in place to ensure other students are on the bus. The bus companies' insurance would be primary on a claim.
