FEBRUARY 23, 2023

1. Open bids, discussion, and action for Block for Softball concession/bathroom building, discussion, and action.

Two bids were received:

Acme Block and Brick (Presented by Mr. Jones)

SRM Concrete (Sealed)

SRM was over all \$370.00 less than Acme,

SRM did not bid on sand.

Acme price on sand \$40.00 per ton.

SRM \$0.52 per wire reinforcing stick.

Acme no price on wire reinforcing stick.

SRM \$168.00 per yard for filler.

Acme did not price filler.

Building will have rafters, but TCAT has requested that it be changed to trusses due to having to cut blocks. Mr. Farmer thought the building should meet the design intent and Mr. Boring stated he agreed.
