# **Purpose of Meeting**

# What Federal Programs does Shippensburg qualify for?

- Title I: Supplemental education program that provides financial assistance to LEAs to improve educational opportunities for educationally deprived students, designed to help children meet state content and performance standards in reading, language arts, and mathematics.
- Title II: Supplemental education program that provides financial assistance to improve skills of teachers and the quality of instruction in core academic subjects.
- Title IV: Supplemental education program that provides funding for three areas, well-rounded education, safe and healthy schools, and the effective use of technology.

## 2024-2025 Preliminary Title I funds

- \$1,072,940 in the preliminary budget for Title I
  - We do not get final allocations until January/February of the academic year
- Preliminary Budget for Title I
  - Title I Teacher Salaries: \$593,235
  - Title I Teacher Benefits: \$196,309
  - I-Ready Reading and Math: \$ 64,665
  - Title I Family Engagement: \$9,900
  - Non-Public Set Aside (Estimate): \$14,401
  - Homeless Set-Aside: \$1,000
- Total: \$879,655
- Transfer \$70,192 from Title IV into Title I

## 2024-2025 Title II Funds Input

• Preliminary Allocation \$123,093

- Idea for moving forward for 2024-25
  - Use funds to pay for ESSER math coach position as they utilized ESSA evidence-based practices with our teachers.
  - Since coach is currently being compensated from Federal funds, we do not need to worry about "Supplement not Supplant"
  - Use funds to pay for Class Size reduction teachers for growing enrollment at JB and NG

## 2024-2025 Title IV Funds

- Preliminary Allocation: \$70,192
- Options:
  - Transfer into Title I: \$52, 530 to fund iReady
  - Transfer into Title II: \$17,662 to fund math coaching or CSR salary
  - Transfer all to Title 1
