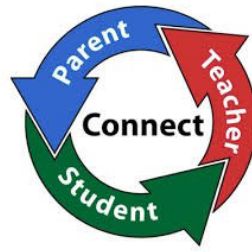
Meetings throughout the year will be held in multiple sessions, varieties of times during the day and evenings, as well as different days of the week.
