The mission of Elk Creek High School and Bidwell Point Continuation High School is to provide a safe, caring and engaging learning environment that promotes student success in academics and understanding. Elk Creek High School serves grades 9-12 and is part of the Stony Creek Joint Union School District. The teacher to student ratio for the school 5:1. The school offers A-G courses and an FFA program. Elk Creek High School is WASC accredited. The school is served by four teachers, 1 part time RSP teacher, 1 part time counselor 1 part-time behavior counselor and a full time RSP Para Educator. The school offers sports such as cross country, girls volleyball and boys and girls basketball, but due to low enrollment sports programs are not consistent. The school prides itself on its small size which caters to those students who like a more personable education environment when compared to neighboring districts with class ratios of 25:1 or larger.

Bidwell Point Continuation High School serves grades 11 & 12 in an alternative education setting and can include grade 10 students with permission. Bidwell Point has its own curriculum that meets the needs of the students better than the standard curriculum used at Elk Creek High School 1 part time teacher teacher and a one hour para educator support the students at the school Students are also allowed to participate in sports at Elk Creek High School.

Through the Catapult system, we are able to summon fire and/or law enforcement immediately, including local first responders who have been trained on the system alongside school personnel. The emergency notification system is sophisticated and has many features, including the ability to determine the location of teachers and students through GPS and an "all call" feature that allows the school to notify and update parents in the event of a school emergency. All staff are trained in ALICE response to active shooter school threats.
