 - A. Collective Bargaining Ms. Rammell explained that any content provisions for her performance evaluation will be done after bargaining is complete.  - B. CSCT Ms. Rammell explained that the cooperative is looking at leveraging other services, such IOT-Intensive Outpatient Therapy, to make the mental health program sustainable. The decline in Medicaid clients since the health emergency was lifted is resulting in financial losses in the program. Mr. Hughes explained that these other services can be provided by current staff, but reimbursement

rates are higher than CSCT reimbursement rates and not subject to MATCH payments. Mr. Hughes and Ms. Gillespie will have a detailed plan for the transition very soon.
