NOW, THEREFORE, BE IT RESOLVED THAT the Board of Education of the Borough of Paulsboro hereby approves the appointment of Dr. Roy Dawson to be its Superintendent of Schools, for a term beginning on or about July 1, 2024 and ending June 30, 2027, subject to the laws of the State of New Jersey and subject to the terms and conditions of the Employment Contract which will be sent to for review and approval by the Executive County Superintendent; and,

IT IS FURTHER RESOLVED that the Solicitor and Board Secretary are hereby authorized and directed to forward the Employment Contract for review and approval to the Executive County Superintendent.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Education of the Borough of Paulsboro hereby approves the appointment of Dr. Roy Dawson to serve as its Superintendent of Schools, for a term beginning on or about July 1, 2024 through June 30, 2027, subject to the laws of the State of New Jersey and subject to the terms and conditions of the Employment Contract which shall be submitted for review and approval by the Executive County Superintendent.
