## **Policy Topic Description**

Extracurricular Programs Policy
Statutory Authority –KRS 160.345(2)(i)8

### **Policy Statement**

This policy is intended to act as a guide for extracurricular programs and activities at Hopkinsville Middle School under the above statute.

# **Extracurricular Programs Policy**

Extracurricular Programs and Activities shall consist of all non-academic activities conducted during school and non-school hours under the auspices of the school both on and off school campus. Examples of extracurricular programs and activities include but are not limited to: Middle School-21<sup>st</sup> Century Learning Community, cheerleading, dance, football, boys and girls basketball, archery, band, choir, academic competitions, JLC, clubs (beta, STLP, etc.) and any community service. High School Clubs which HMS students participate in: baseball, softball, wresting, swim, boys and girls tennis, Science Olympiad, HHS band, HHS color guard, and boys and girls soccer.

The Principal or through the designee (AP, or Leadership Committee) will:

- o Review, and recommend guidelines for extracurricular programs and activities.
- o Recruit sponsors for extracurricular programs and activities.
- o Evaluate the needs and interests of students.
- o Assess the rules, activities, and expectations of programs.
- Inform Coaches and Parents of expectations both academically and behaviorally.

The Principal or designee will report to the council any changes or recommendations to this policy as needed.

Job descriptions of coaches, and pay grades will be obtained from the Christian County Personnel office.

Coaches and Sponsors will meet CCPS guidelines and have a back ground check in order to meet the safety needs of working with young students. Coaches will supervise students under their care until all students are released to their parents. Practice times, games, travel time will all be supervised.

**No Pass No Play** - Hopkinsville Middle School Coaches will enforce the no-pass, no-play guidelines at HMS. In order for students to participate in any extracurricular programs, they must be passing all core content classes they are assigned to during a nine week period. Grades will be pulled by coaches weekly and checked before students are allowed to play the following week.
