School District Grants

Our summer schedule was full of professional development opportunities to enhance teaching and learning. Our walkthrough program will help us to support our teachers as they implement our new curriculum, instruction and assessment initiatives. Building Aid Update

Our Leadership Team met with the architects on Thursdays to review various design options in preparation for the presentation at the next Building Committee Meeting which will be held on Wednesday, September 14 at 5:00 pm in the Colebrook School Library. Once the design has been completed. The Building Committee's recommendation will be brought to the next school board meeting on September 20. Once the building design has been finalized, we will prepare materials for communication with the community.

On September 7 the NH DOE Consultants from the Bureau of School Safety and Facility Management will tour Colebrook School as part of the assessment process to evaluate the building aid application. We will receive the results in January, 2023.

Included following my report is the NH DOE School Building Aid Process and timeline. DOE grants 80% of the State Building Aid award based upon published ranked list and final DOE approval and the final 20% upon completion. Payment contingent upon successful town vote, signed contract with contractor, and availability of building aid. School breaks ground after final approval. Therefore, we will not be required to bond the full cost of the project.
