

## **Kearney Archway**

SNRP hosted a one day event for students in Kindergarten through 5th grade at the Kearney Archway on February 16. Due to weather and illness, we had several cancellations but we had 35 students who attended. The overall goal of this activity was to help students understand the history of how families traveled across the United States, including right where the Archway is, by covered wagon in hopes of finding a better life for their family. Through the tour as well as the activities, students learned that families had to leave a lot of their belongings behind because they couldn't fit it in their wagons or their wagons would become too heavy. This meant that children often had to create their own fun and games. Students learned about and made a common toy that pioneer children played with, a whirligig. Students also played a common game that pioneer children played on their travels called "Button, Button, Who Has the Button?". Through the tour students also learned how transportation has changed over the years to include railroads, the first cars, and interstates and how this has impacted people's lives.



CWNP hosted Weekend to Sign at Camp Comeca in Cozad on January 27th and 28th. Eighteen families were able to attend, and we were thrilled that the weather cooperated!

Parents were immersed in two days of learning and practicing practical, everyday vocabulary with Colleen Richart and Cindy Koch. They learned signs to use for family craft time and board game time, and they developed new connections.

While parents were busy in their sessions, the children were too. The children were split up into groups, and Deaf and Hard-of-Hearing adults led them in fun activities, games, songs, plays, and crafts, all while learning to sign. It was a great opportunity for some of the children with hearing differences to help their siblings and other children learn their language!

Families had the opportunity to learn about Deaf culture and participate in a silent supper by wearing earplugs and signing without voicing. This was an eye-opening experience that families enjoyed. Following supper, Aaron Rothenberger from NCDHH, Jessica Hoss from Hands and Voices Guide by Your Side, and Jonathan Arteaga and Colleen Richart from NeAD and the Deaf Mentor Program shared information about their programs with families and then joined them for an evening of board games.

The weekend wrapped up with a performance in sign language for all! The 3-5-year-olds signed "5 Little Monkeys Jumping on the Bed," the 6-9-year-olds performed "Goldilocks and the Three Bears," and the 10 and up group took the audience through a Zoo! The students are learning parliamentary proceedings and learning from DHH peers and adults.

"Don't Be Mad If I Don't Look: Interpreting for Hard of Hearing Students": The MRP hosted a virtual workshop for interpreters and other related professionals on interpreting for hard of hearing students. The workshop was presented by Corey Axelrod.

Coordinator Involvement: Diane attended the NCDHH Mental Health Advisory committee as the education representative. Diane is accompanying Service Coordinators on home visits to introduce families to the NE Regional Programs and to begin building relationships. Diane continues to participate in the quarterly update meetings with the grant and contract coordinators at ESU 3. She presented to the Services Coordinators, Early Childhood Special Education teachers, Speech-Language Pathologists and School Psychologist from ESU 2 on the Language Assessment Program. Diane attended the Tri-State Law Conference and Nebraska Association of Special Education Supervisors annual Legislative Conference in Lincoln. The conference highlights current bills that would have an impact on education. Diane has participated in online trainings including Hearing Assistive Technology Systems, Theory of Mind Development in Children with Hearing Differences, Fundamentals to Cutting Edge Practice and a training webinar on the Test of Auditory Functioning to train and support professionals in using the tool for the annual Language Assessment Program.

**Student Activities at School:** Diane continues to go to Western Hills Elementary, Beveridge Middle School, and Burke High School to provide activities during school hours. The activities focus on teacher and coordinator identified areas of needs such as understanding paychecks (transition skill), developing a budget (transition skill), problem solving (abstract language and thinking), self-advocacy and accommodations, and concept/directional vocabulary.

#### **SNRP Updates**

## UNO UPDATES

## **Grant Update**

UNO received a CSFRF grant to

be used for mentoring for interpreting students. Once funds are released, interpreting students will complete a readiness survey and the American Sign Language Proficiency Interview (ASLPI) to establish a baseline of existing ASL skills. Each month, UNO students will participate in one hour of mentoring with a trained mentor. At the end of the mentoring cycle, UNO students will complete the survey and the ASLPI again as a post-test. We believe that with this intentional mentoring, students may feel more confident to take the EIPA or NIC sooner than is currently happening which will ultimately address the interpreter shortage

in Nebraska. Institutional Review

Board (IRB) approval has been

granted so this project can also

be used for research purposes.

## Other Updates

\* D/HH undergraduate endorsement is being phased out due to the budget. Students already enrolled will be able to complete the program but no new students are being accepted.

\*Beginning 2023–2024 UNO is using True+Way ASL curriculum this semester. The decision was made to move from Signing Naturally because True+Way ASL is a Deaf created, digital program embedded in the Canvas learning management system used at UNO. Lessons include more conversations with more inclusive videos from a wide variety of signers. There is also a searchable ASL-English dictionary that is also part of the Canvas course.





## **UNL Update**

- The UNL Department of Special Education and Communication Disorders is currently in the process of vetting recipients to be part of the second <u>MPUP-SPADE</u> cohort. Scholars will begin program activities this summer. We had over 40 applicants (7 for the AUD program, 11 for the TOD, and 23 for the SLP)! We anticipate funding a total of 12 scholars (2 AUD, 5 TOD, and 5 SLP) in this second cohort.

## Mental Health Advisory Team

The Mental Health Advisory Committee has two openings for a counselor related to mental health, alcoholism and drug abuse.

The committee consists of five members, three counselors familiar with mental health, alcoholism, and drug abuse disorders in deaf and hard of hearing people and two human services professionals. Health and Human Services and NCDHH shall each have a representative who serves on the committee in a nonvoting technical capacity. Members are appointed by the Commission Board Members.

Our interview panel has hired 5 Deaf mentors effective Feb 1st: 2 in Scottsbluff, 1 in Lincoln, and 2 in Omaha

Colleen Richart and the Deaf mentors completed 3-day weekend SKI HI Curriculum training (Feb 16-20) provided by Paula Pittman and Danelle Gournaris. It was very intense but valuable information. We, the NeAD board, and advisory committee are appreciative for the support from NE EHDI (Early Hearing & Detection Intervention), Nebraska Dept of Special Education, NeAD Advisory Committee for the Mentor program, Hamilton Relay, NCDHH, LAD, NE H&V, and interpreters to make this workshop successful.

Future training will contain mini sessions with SKI HI, HIPPA/FERPA, Home Visit Safety and many more. We are currently looking into developing a web page under NeAD's website to promote our program and to share our mentors' background to help families know who we are. #### **DEAFBLIND CHILD COUNT**

The Deafblind Child Count is a separate reporting system from any other state data that specifically looks at the number of students who have a combined vision and hearing loss. This is required by the U.S. Department of Education, Office of Special Programs, through a federal state grant.

You will find the Deafblind Child Count form online: https://cehs.unl.edu/nedeafblind/child-count-0/

This form should be completed for any student on your caseload with a combined hearing and vision loss, regardless of whether they were determined eligible under the deafblind category. Any degree of severity of vision loss and any degree of severity of hearing loss can be combined for a student to have a dual sensory loss. If you cannot remember if a child has already been registered with deafblind project, please contact Mackenzie to ask: msavaiano2@unl.edu. If a child you work with graduated, moved, or is no longer receiving services, please complete a form online.

By completing the Deafblind Child Count form, you help Nebraska to have an accurate count of students with a dual sensory loss. You can also help the student's team to access resource materials, receive technical assistance from the Nebraska Deafblind Project, participate in professional development opportunities, and assist parents with networking. Please know that all information collected on the Deafblind Child Count form is kept confidential. No student names are shared. We also request that you inform parents/guardians whenever completing a form about their child and document that conversation for your files.

#### **UPDATES**

- Speech-Language Department: In 2023, we saw 142 youth with hearing loss that are ages 19 and under for SLP services. So far for 2024, we have seen 43 youth with hearing loss for SLP clinic services. We now have our third location open on 168th & Maple Street, in addition to the LLTC (30th St Hospital Campus) and West Speech-Language Clinic (Home Campus near 144th & Dodge).
- Cochlear Implant Team: As a result of innovations and improvements that the CI manufacturers have
  made in their cochlear implant clinical programming software and in smartphone apps that can
  communicate with cochlear implant equipment through Bluetooth, we now have the capability to do
  remote testing and adjustment of cochlear implant equipment. Recipients can now receive at least some
  CI services via telehealth without needing to physically be present in the clinic. The CI Team is in the
  process of developing protocols, documentation, and infrastructure that will allow us to begin routinely
  using the remote programming option with some patients for some types of procedures.

- <u>Student Signer Project</u>: EIPA is searching for students to record while using sign language. The recordings will be used to create new training and testing material to support the skill development of educational interpreters.

#### **Educational Programs**

- Parent Infant: We currently have 16 families with children who are deaf or hard of hearing, with 2 additional families starting this month.
  - Although the majority of these families are from OPS contracts, Boys Town continues to be available to other school-district contracts. Those who might be interested in contracting for 0-3 services should contact Amy Tyler Krings.
- Preschool: We are going into our second year as a full day program and continue to offer rolling enrollment, meaning preschoolers can enter as soon as they turn 3 years old. We have 4 classrooms this year. Currently have 21 students, with 1 additional student starting in a few weeks. Student placements are IEP-driven and facilitated by a student's local school district. School districts and families are welcome for tours. Tours and preschool inquiries can be made by contacting Amy Tyler Krings at Boys Town (amy.tylerkrings@boystown.org).
- School-based Counseling: Boy's Town Counseling team consists of two therapists that are contracted with the Metro Regional Program (MRP) to provide counseling support for DHH students in the Metro region schools. Currently, they are seeing 52 students spread across 15 different schools. Referrals can be made by teachers contacting Diane Meyer and/or families can also reach out to Diane Meyer.
