J. TRUSTEE RESOLUTION CALLING FOR AN ELECTION:  
BE IT RESOLVED,

The Board of Trustees for School District #50, East Glacier Park, Glacier County, State of Montana, will hold the Annual Regular School Election on: Tuesday, the 7th day of May, 2024 which date is not less than seventy (70) days after the passage of this resolution.

THE ELECTION: will be conducted by Mail Ballot.

PURPOSE OF THE ELECTION:

The purpose of the election is to elect one (1) trustee for a three (3) year term.

Approval of additional levies to operate and maintain the General Fund, the Technology Fund and the Building Reserve Fund for FY 2024-2025 will also be requested.

CANCELLATION OF ELECTION:

If it is later determined that any portion of the election is not required, the Board of Trustees authorizes Denise Mason, Election Administrator, to cancel that portion of the election in accordance with 13-1-304, MCA and 20-3-313, MCA.

BUDGET AMENDMENT PROCLAMATION

EAST GLACIER PARK GRADE SCHOOL DISTRICT #50, GLACIER COUNTY

At a regular meeting of the board of trustees of School District No. 50, Glacier County, Montana, held January 22, 2024 at 6 p.m. in the lunchroom of the East Glacier Park Grade School, the following resolution was introduced:

WHEREAS, the trustees of School District No. 50, Glacier County, Montana, have made a determination that as a result of a deferred project from a previous budget of the district, the district's budget for the General fund does not provide sufficient financing to properly maintain and support the district for the entire current school fiscal year; and,

WHEREAS, the trustees have determined that an amendment to the Elementary School General Fund budget in the amount of \$42,997.85 is necessary under the provision of Section 20-9-161(5(d)), MCA; for the purpose of funding toward the purchase of two new student activity buses; and,

WHEREAS, the anticipated source of financing the budget amendment expenditures shall be General Fund Excess Reserve Funding;

THEREFORE BE IT RESOLVED that the Board of Trustees of School District No. 50, Glacier County, Montana, proclaims a need for an amendment to the Elementary School General Fund budget for fiscal year 2018-19 in the amount of \$42,997.85 under Section 20-9-161(5(d)), MCA, for the purpose identified above, and;

BE IT FURTHER RESOLVED that the Board of Trustees of School District No. 50, Glacier County, Montana, will meet at 6 p.m. in the lunchroom at East Glacier Park Grade School on February 26, 2024 for the purpose of considering and adopting the budget amendment.

Citizens may comment on items appearing on the agenda when invited to participate during that agenda item by the Board Chair. Citizens may comment on items related to School District business not appearing on this agenda during the public comment portion of the meeting. Public meetings may be recorded or broadcast by citizens in accordance with Montana law. Citizens broadcasting or recording a meeting are encouraged to notify the board chair so appropriate accommodations and notifications can be made.

Montana law requires school districts and other public agencies to include on the agenda for public meetings an item allowing public comment on any ***public matter not otherwise specifically listed on the agenda*** that is within the jurisdiction of the agency. As has also been the practice of the District, and in accordance with Montana law, if any Board or public representative desires to speak to an item that is ***specifically listed/identified on the agenda***, you will be allowed to do so at the discretion of the Board chairperson when the item comes up for discussion and action. The public comment portion of the agenda is not the time designated to hear items that are specifically listed/identified on the agenda.

For those individuals who desire to address the Board during the “public comment” portion of the meeting, if you haven’t already done so, please sign your name to the sheet located on the table and indicate the general topic on which you will be commenting. The Board Chairman will call individuals to speak in the order listed on the sheet provided. The Board would like to remind everyone in attendance that to avoid violations of individual rights of privacy, a member of the public wishing to address the Board during this time will not be allowed to make comments about any student, staff member, or member of the general public during his/her designated time to speak. In addition the Board will not hear comments on contested cases or other adjudicative proceedings.

Depending on the number of persons who wish to address the Board, the Board Chairman may place reasonable time limits on comments, in order to maintain and ensure effective and efficient operations of the Board.

By law the District cannot take any action on any matter discussed during the “public comment” portion of the meeting, until such time as the matter is specifically noticed on the agenda, and the public has been allowed the opportunity to comment.

Board meetings are open to the public, but not a public meeting.
