Not all ESP sites will be open for the summer program. An ESP site must maintain a minimum of 12 children in paid attendance each day for the site to be open. Parents will be notified which ESP sites will be open for the ESP Summer Program.

Please select the days your child will be attending the ESP Summer Program. We must know the days you will need services to meet state guidelines on the number of ESP staff required. Thank you for your cooperation. Please note that payment will be due for the days you select on the Friday prior to the week of childcare service. And for the days your child is enrolled you must make payment even if your child does not attend. Hours of operation: Monday thru Thursday 3:00 – 6:00 PM and Friday 7:00 AM – 6:00 PM. Breakfast and lunch are provided by the Franklin County School Nutrition Program during the month of June on days the Summer Learning Camp is in session. All Fridays and during the month of July children must bring a sack lunch. Morning and afternoon snacks will be provided.
