Mrs. Lind reports:

- Current enrollment 170
- His Eminence celebrated prayer service with a beautiful breakfast. Thank you to the school board for pursuing this wonderful opportunity for our school. He visited all classrooms and students asked questions. We ended with an all-school photograph and breakfast on the patio with parents and members of our service organizations (NJHS and Student Council)
- MAP testing, finishing Kindergarten (Chromebook difficult time with screen and mouse)
 Every other grade is finished. It has been a challenging transition from desktops to Chromebooks.
- Mid terms will be posted in PowerSchool. Our tech team has experienced Powerschool technical difficulties. Issues are beginning to be resolved.

When we looked at the research for the testing it's more for controlling the spread of the virus. Koraes will continue to follow CDC guidelines. If anyone is feeling ill in the home, keep your children home. Require a PRC test in an instance that you are told you need one to return to school not a rapid administered by a lab prc test. Visit a clinic, pediatrician, not a home test from cvs or walgreens. Recommendation to have a PCR detects accuracy. Anything involving covid or dealing with quarantine needs to go through the school office. We need parents to cooperate. Vaccination 5-11 year olds may change our policy of covid.
