- 1. Resolution for Service Fund (ORC 3315.15). Be it resolved that the Southern Local Board of Education wishes to set aside from the General Fund, according to ORC 3315.15 the sum of \$20,000.00; this amount to be placed in a "Service Fund" which shall be used only in paying the expense of members of the Board of Education in the performance of their duties as official representatives, or those expenses actually incurred in training and orientation to improve their performance as Board of Education members.
- 2. Advancement of taxes collected (ORC 321.34). Be it resolved by the Southern Local Board of Education that the Treasurer be authorized to request from the Columbiana County Treasurer advances of local taxes as needed.
- 3. Investment of Funds. Be it resolved that the Southern Local Board of Education hereby gives the Treasurer the authority to invest moneys of the Southern Local Board of Education, when it is advisable to do so and when it is in the best interest of the school district.
- 4. Employment of Temporary Personnel. Be it resolved that the Southern Local Board of Education herby gives the Superintendent the authority to employ such temporary personnel as may be needed to cover emergency and unique situations.
- 5. Payment of Bills (ORC 3313.18). Be it resolved that the Southern Local Board of Education, as authorized under Section 3313.18 of the Ohio Revised Code hereby dispenses with the adoption of resolutions during calendar year 2025, authorizing the payment of depts or claims from school funds, within the Appropriations Resolution adopted by the Board of Education for 2024. Use of a facsimile signature is authorized in the payment of all warrants. Authorize the treasurer to use blanket purchase orders not to exceed \$250,000.00 per blanket.
- 6. Attendance at meetings. Be it resolved that the Southern Local Board of Education authorize the Treasurer, Board Members, and Superintendent to attend professional meetings as needed during calendar year 2025.
- 7. Designated Newspaper. Be it resolved that the Southern Local Board of Education designate the "Morning Journal", and the "Review" as the official newspapers of the district for 2025.
- 8. Designate a Depository for Funds. Be it resolved that the Southern Local Board of Education declares Consumers Bank and U S Bank as the depository of public funds for the district for 2025.
- 9. Authorization to Borrow Funds. Be it resolved that the Southern Local Board of Education authorize the Treasurer and Board President to borrow money as needed provided that each Board Member is notified 48 hours before the loan is obtained.
- 10. Adjustment of Appropriations. Be it resolved that the Southern Local Board of Education authorizes the Treasurer to make all necessary modifications of appropriations.
- 11. Authorize Greg Sabbato and Julie Dowling as public records designees.
