5. Discussion and possible decision on whether to hold fall athletics (soccer and volleyball)

The Principal, Mr. Matt Yost and the Athletic Director, Ms. Cyndi Moreno discussed the current situation with the Arizona Interscholastic Association (AIA), as well as athletic competition plans of other surrounding school districts.

The Board asked several questions*, including:

Q: What are AIA recommendations for transportation if we participate in competitions?

A: The AIA is advising against school bus transportation, recommending parent or if appropriate, student self-transportation to minimize contact on long drives to competition.

Q: On AIA membership, do we still need to pay dues?

A: Ms. Henry: We are still working on this. We would be hard pressed to be held to payment for amounts owed. Ms. Moreno: We have two forms of payment, membership dues and competition dues. If we expect to participate in sports possibly in Spring of 2021, we should pay the membership dues, but if we cancel soccer and volleyball, we would not make participation payments.

Board member, Mr. Shearer expressed a concern that athletics are a motivator for students who are otherwise performing marginally academically. He did acknowledge that the health and safety of our students is priority, so he supported the action, but wanted to suggest the school consider other means of ensuring student effort in academics.

6. Discussion of condition of 400 building

Mr. Ivan Landry, Maintenance Director, discussed the current status of the 400 Building.

In the process of air conditioning unit replacement this summer, it was discovered that several support beams in the 400 building have cracks. The beams have been temporarily shored up, however at this time we are not considering the building to be safe for students.

We are waiting on further engineering evaluation by the Arizona School Facilities Board. Potential repairs could consist of epoxy glue repair, or glue repair with additional support steelwork, to full beam replacement.

Mr. Landry will update the School Board when additional information is available.

7. Use of Policy BGF (Suspension/Repeal of Policy) to suspend Policy IKF (Graduation Requirements) for the 2020-2021 school year

The Principal, Mr. Matt Yost discussed graduation requirements, as possibly affected by Distance Learning. Because the Distance Learning schedule does not include Phantom Academy, the there are two current GCHS students who transferred into GCHS, who are short credits to graduate in 2022-2023.

Mr. Yost recommended suspending the graduation requirements of Policy IKF until the school returns to in-person learning.

Mr. Yost also noted that community service requirements are being affected by the social distancing requirements of the pandemic, and recommended that the class of 2020-2021 be exempt from the current 40-hour requirement.

After discussion, the Board tabled action until next board meeting and gave directions to staff as follows:

Prepare a modification of policy IKF to address phantom academy and community service, prorating service requirements for new arrivals. There should be a short term, and long term policy.

8. Discussion and possible decision on Coronavirus Tax Relief

Ms. Judi Beckerleg, Acting Business Manager, reported to the Board her recommendation on action regarding the US Presidential, Coronavirus Tax Relief Memorandum. Ms. Beckerleg reported that the program would take effect on September 1 and run through December 31, 2020. Employers and employees have the option to defer withholding, deposit and payment of Social Security tax for the four months the program would be in effect.

An important aspect of this program is that it is a deferral, not a forgiveness of tax liability. Unpaid tax would have to be collected and repaid by April 30, 2021. Ms. Beckerleg reached out to our auditors who recommended we not participate. Employees who would most benefit from the program, will be the

most impacted in the new year when deferred taxes would be deducted from their pay. Based upon the information obtained, it was Ms. Beckerleg's recommendation that the District does not enter into the program.

The Board also heard comments from the school attorney, Ms. Tosca Henry, Esq., regarding her analysis of the Presidential Memorandum on Deferring Payroll Tax Obligations issued on August 8, 2020, and, the Notice 2020-65 implementing the Memorandum and the potential impact to the District. Ms. Henry echoed Ms. Beckerleg's recommendation against participating in the program, as the District would ultimately remain responsible to ensure that the deferred amounts were repaid between January 1, 2021 and April 30, 2021, in addition to the usual withholdings per pay period.

The direction given to staff was not to participate in the program.

9. Food Services Update - Good News!

The Food Service Director, Barb Shields was not available, so Dr. Shonny Bria filled in. Dr. Bria notified the Board that the Federal Government removed limits on food payment for ALL students until the end of the 2020 calendar year. As a result, we will be providing breakfast and lunch to all students beginning on September 8.
