# Dual Enrollment

Georgia's dual enrollment program allows high school students to earn college credits while working on their high school diploma.

# HCCA Dual Enrollment (Career Academy)

Houston County Career Academy is an extension of the programs of high schools in Houston County located at an off-campus center of Central Georgia Technical College.

# HCCA Dual Enrollment (Career Academy)

## HCCA Admission Requirements

The student must:

- ▶ A student must be a 10th, 11th or 12th grade student to enroll in an approved DE course.
- ▶ A 2.3 GPA or higher is **required** for dual enrollment courses.
- ▶ A 2.3 GPA or higher is **preferred** for non-dual enrollment courses.
- ▶ Commit to a pathway offered at the Career Academy.

# On Campus Dual Enrollment (College Courses Taken at Veterans High School)

- ▶ Juniors and Seniors who meet the admission requirements for Central Georgia Technical College must enroll in the following dual enrollment courses or Advanced Placement.
- ▶ DE US History
- ▶ DE Economics
- ▶ DE Sociology

***Each course is taught on the High School campus.***

***Students do not leave campus.***

# College Campus Dual Enrollment (On Campus Courses)

- ▶ Dual Enrollment (DE)
  - ▶ Taught on college campuses or online according to college schedule
  - ▶ Students are released from high school 2 periods for each college class and required to make a yearlong commitment to attending classes for those release periods (minimum 2 college classes – 1 per semester)
  - ▶ Students are responsible for admissions, transportation and all communication with faculty during enrollment
  - ▶ Course grades do not exceed 100
  - ▶ Withdrawing from a college course could result in a Z code on the transcript
  - ▶ College credit is awarded upon successful completion of the course
  - ▶ Registration completed outside of Evening Advisement

# To Be Eligible:

- Any student attending a public or private high school in Georgia or an eligible home study program
- Must be approved and classified as eligible by the high school
- No residency or citizenship requirement
- Students must sign an advisement form with their high school
- Meet admissions requirements at postsecondary institution
- Must meet Satisfactory Academic Progress as required by the college or university
- Must not have already received a high school diploma



# Things to Consider

Dual Enrollment is a yearlong commitment. Students attending college classes during specific periods of the school day 1<sup>st</sup> semester will be expected to take classes during those periods 2<sup>nd</sup> semester

# Things to Consider

For every **college** class a student takes, he/she will be released for **two periods** of the high school schedule

# Things to Consider

- ▶ No quality points are added to Dual Enrollment courses

*For example, in high school AP classes and Honor classes have added quality points*

- ▶ The high school does not provide transportation, materials, or academic assistance for classes taken at college

# Things to Consider

- ▶ Deadlines are important! Participation in Dual Enrollment is subject to deadlines imposed by colleges and the high school.

**Deadline for SUMMER and FALL 2021**

**May 15**

# Funding Cap Eligibility

How many hours will be paid for by the Dual Enrollment funding Program?

- ▶ The Dual Enrollment Funding Cap is 30 semester or 45 quarter hours.
- ▶ The Funding Cap is a hard cap based on hours paid by the Dual Enrollment funding program for terms of enrollment (as invoiced by the postsecondary institutions).
- ▶ The Funding Cap does not include dual credit coursework attempted and paid by other sources.

# Grade Level Eligibility

- ▶ Students who are enrolled and physically attending a participating eligible public or private high school in Georgia or an eligible participating home study program in Georgia may participate.
- ▶ **11th & 12th Graders**  
Eligible students may take any approved Dual Enrollment courses listed on the Course Directory, at an eligible participating postsecondary institution (USG, TCSG or private).
- ▶ Students in the **9th grade are not eligible** to participate in the Dual Enrollment funding Program.

# Grade Level Eligibility (continued)

## 10th Graders

- All eligible 10th Graders may enroll in approved Career, Technical and Agricultural Education (CTAE) courses listed on the Course Directory at a participating TCSG institution only.
- 10th Graders who have a minimum SAT score of 1200 or minimum ACT composite score of 26 in a single national test administration, may enroll in any approved courses listed on the Course Directory at a TCSG, USG or private eligible participating postsecondary institution.



# What type of student is a good fit for Dual Enrollment?



- ▶ Meets college DE admissions requirements
- ▶ Responsible
- ▶ Takes initiative
- ▶ Can follow through on multi-step tasks
- ▶ Self-motivated
- ▶ Able to communicate with professor
- ▶ Has a specific pathway planned for graduation
- ▶ Can overcome any logistical challenges of traveling to and from high school and college
- ▶ Mature

# Course Options

Curriculum of courses that could be used to satisfy graduation requirements and courses identified in the Dual Enrollment Course Directory include:

- **English**
- **Mathematics**
- **Science**
- **Social Science**
- **Foreign Language**
- **Career, Technical, Agricultural courses**
- **Electives**
- **Fine Arts (*Music Appreciation and Art Appreciation*)**
- **Online Courses**

*\* Students will receive credit only for courses listed in the directory*

# Dual Enrollment Course Directory

Dual credit enrollment hours taken at a postsecondary institution and paid for by Dual Enrollment funding are not counted as HOPE attempted-hours, nor are the hours included in the combined HOPE paid-hours limit.

# Satisfactory Academic Progress

Students must maintain a **2.0 GPA** or higher each semester



# Counselors Do Not Control

- ▶ The college schedule and course availability
- ▶ The acceptance process
- ▶ Troubleshooting any holds on admissions or registration
- ▶ Communication between you, your parents and the college about absences, tardies, textbooks, transportation, a missed test, grades, etc
- ▶ If DE courses transfer to other colleges or degree programs
- ▶ Students are responsible for checking the transferability of courses.

# Application Process

- ▶ Apply for admission online
- ▶ Complete the college admissions exam (Check with colleges about test requirements)

*\* CGTC and Middle Georgia State have waived test requirements.*

- SAT
- ACT
- PSAT
- ACCUPLACER

**SAT and ACT test scores must be sent electronically through College Board or ACT.**
