Continuous Eligibility for Dual Enrollment for Dual Credit

Students who meet the criteria for initial admission for the Dual Enrollment program will maintain continuous eligibility so long as they earn a grade of C or better in all attempted college courses. Students who fail to meet this minimum grade requirement will be suspended from the dual enrollment program for a minimum of one semester. The one-semester suspension may not be served during the summer semester. The student may not re-enroll until the suspension has been served. For re-entry, the student must re-apply to the program and meet the minimum (unweighted) grade point average requirement.

Authorization for Release of Records

According to the Family Educational Rights and Privacy Act of 1974 (FERPA), all rights of access to students' educational records transfers from the parent(s) to the student when the students become 18 years of age OR are enrolled in an institution of postsecondary education. In order to comply with the requirements of FERPA, Reid State Community College shall obtain written consent from students before disclosing any personally identifiable information from their education records.

As a participant of the Dual Enrollment program, I authorize Reid State Community College to release my grades to my high school and/or secondary educational entity. This release shall remain in effect until I provide written notice to the Records Office to discontinue the release or until I earn my high school diploma.
