- 1. Call to Order- Roll Call: Lisa Gerving and Lori Unruh called the meeting to order at 7:01 pm.

 - b. Elementary Girls Basketball Marie Bittner and Daryl Schulte made a motion, seconded by Carrie Gerving and Laken Wehri, to approve to hire Shelly Christensen as the Elementary Girls Basketball Coach. Motion unanimously carried.
 - c. Jr. High Boys Basketball Currently advertising.
- 7. Ordering new track equipment: Track equipment estimate is \$7200. When a final number is obtained it will be brought to each board for approval.
- 8. Summer HIT Program Weight Lifting program: The weight lifting program is scheduled to resume for the 2020-2021 school year.

 - a. Wait 24 hours to make contact with a coach.
 - b. Have the student athlete first meet with the coach to address a concern.
 - c. If the student is not satisfied with the decision, parent can schedule a meeting with the coach. At the coach's discretion, they can either meet with parent individually or have the A. D. be in the meeting with the parent.
 - d. Parent can appeal the decision to the A. D. after meeting the coach.
 - e. Parent can appeal the decision to the superintendent for a final appeal if so desired.
- 13. Suspension Change in policy: Marie Bittner and Ashlie Palmer made a motion, seconded by Travis Thomas and, Daryl Schulte to approve to change both schools handbook policy to include both in and out of school suspension as just "Suspension".
