 Operations - Fiber Project update: Andrew Campbell reported that the fiber project between Hatch and Garfield is complete and is functioning and running perfectly.
 Garfield Elementary is now communicating for the Districts data center in Hatch with the Districts own fiber, a request was made to disconnect Centurylink from Hatch to Garfield, a savings of about \$1700 per month for internet services.

- Instruction- HVHS re-entry update: Fire inspection is scheduled for Thursday, February 18th, a requirement for reentry. The inspection will be conducted by a local fire chief.
 - Shara Montoya, Principal at HVHS presented to the Board the HVHS Hybrid Reentry plan SY 2020-21, High school students will be returning to school on February 22nd; 9th & 12th grade students are scheduled on Monday & Tuesday; 10th & 11th grades students are scheduled on Thursday & Friday from 12:35-3:30. Students participating in athletics will be released at 2:30. A discussion was held.
- Athletics update- Ben Trujillo, AD reported football and soccer have started practicing, volleyball will be starting soon; all coaches have done their surveillance testing, NMAA will be working on schedules for the upcoming games.
