- Conducts perimeter and inner school checks to ensure premises are secure. (3)

- (5) Communicates school policies and procedures, personnel and visitors for the purpose of ensuring their understanding of the potential consequences of violation.
- Informs personnel, parents and/or visitors of school policies and procedures for the purpose of providing necessary (6) information in compliance with policies and guidelines.
- Investigates unusual incidents unauthorized visitors, violent threats against students, etc.) for the purpose of assisting (7) responding law enforcement personnel, developing information necessary to assist in determining appropriate action, and/or providing documentation for future reference.
- (8) Monitors students within a variety of school environments (e.g. rest rooms, grounds, hallways, library, cafeteria, parking lots, etc.) for the purpose of ensuring the safety and welfare of students.
- (9) Prepares a variety of documents (e.g. security logs, memos, letters, procedures, etc.) for the purpose of documenting activities, providing written reference and/or conveying information.
- Reads and responds to email communications. (10)
- Recommends policies, procedures and/or actions to school administration for the purpose of providing information and/or (11)direction that ensures efficient provision of campus security.
- (12)Utilizes and monitors surveillance technology.
- Operates metal detectors and conduct appropriate searches when directed to do so. (13)
- Provides support in school and district emergency situations and participates in all school emergency drills (fire, lockdown, (14)active shooter, hostage etc.).
- (15)Performs other duties as assigned.

The School Safety Guardian is an armed position requiring appointment by the Superintendent and training by the Sheriff of Gadsden County as outlined in the Marjory Stoneman Douglas High School Public Safety Act. Please note, this is not a law enforcement position.
