- I. CALL TO ORDER:** President Ellen Cooley called the meeting to order at 5:30 PM
- II. ROLL CALL:** Vice President Larry Goodman called roll and confirmed a quorum: Present Ellen Cooley was present; Vice President Larry Goodman was present; Board Member Arlene Laughter was present; Board Member Loretta Hoschain was present; Board Member Kenneth Begishe was present.

### III. PUBLIC HEARING

Consultant, Karen Smith of Heinfeld Meech & Co., presented a Power Point on the Shonto Governing Board of Education, Inc. 2012-13 Budgets. Charter School Annual Budget spreadsheets were distributed to the attendees. After the meeting there was some board questions:

LG: Put aside last five years if there were something curious with the budgets.

KS: We can look at the revenue of what was coming in.

LG: We are curious whether there was any influence that caused it to fluctuate.

KS: You might look at enrollment versus expenses according to funding

LG: If you can do that we would be much obliged.

AL: An annual budget work session - we have been requesting for the last several years. We finally got it. We hired Heinfeld & Meech. Now that we have a new finance manager, we are concerned about travel and overtime. Are we really purchasing materials for the students - textbooks, software, instructional and supplemental materials? How much did we spend on our consultants? Was it effective in providing services for our teachers? Those are the questions we have. We have to look at our budget; our plans and align our budget. Are we achieving our goals? There was a new strategic plan; did we develop that plan to spend unrestricted and restricted funds appropriately? E-Rate how much money was returned?

KS: 2004 procurement from that time forward, we don't know if there are further back logged. I know that we have complaints for this particular year. Were the submissions and appropriate forms completed on time? We don't know what further judgments are forthcoming

AL: Now that we have hired a business manager – Are payouts for leave done correctly? Are we wasting money? We are cutting people here. We need to watch our wasteful spending.

KS: We are here as long as you need us here. We established procedures in the business office however, (newly proposed district) policies have not been adopted; procedures already in place in the office and are training the staff. We are waiting for board approval.

LG: I would like to see a copy of that before the next board meeting.

LH: Did Mr. Vaughn get a copy of the policy to look over for the board?

AL: The draft was presented to us at the last meeting for a first meeting. We tabled it because we needed to review the policy thoroughly. We needed attorney review before we approve that policy. We seem to just rubber stamp things and later it comes back to bite us. Federal, state, government, and tribal – we tend to approve it and then later there is chaos.

JV: I have, in fact, have been undertaking that integration particularly of Navajo nation code; I have gone through the 176 page policy. Ms. Smith and I have already redlined that document for the revisions and I assure you that I will get those in the hands of the board members.

EC: Any more questions? If not let's adjourn the public hearing.




