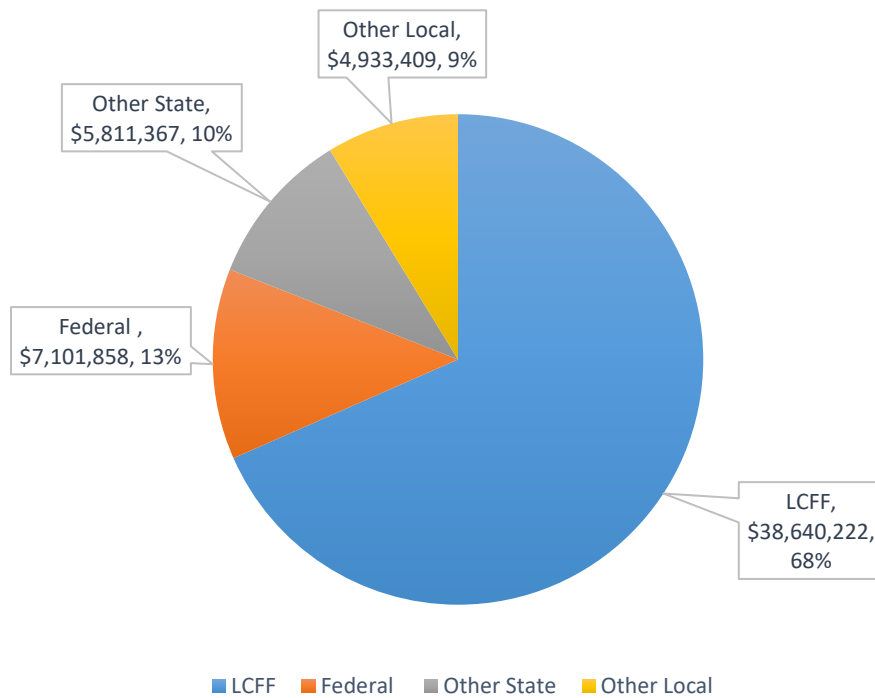
Unaudited Actuals Overview

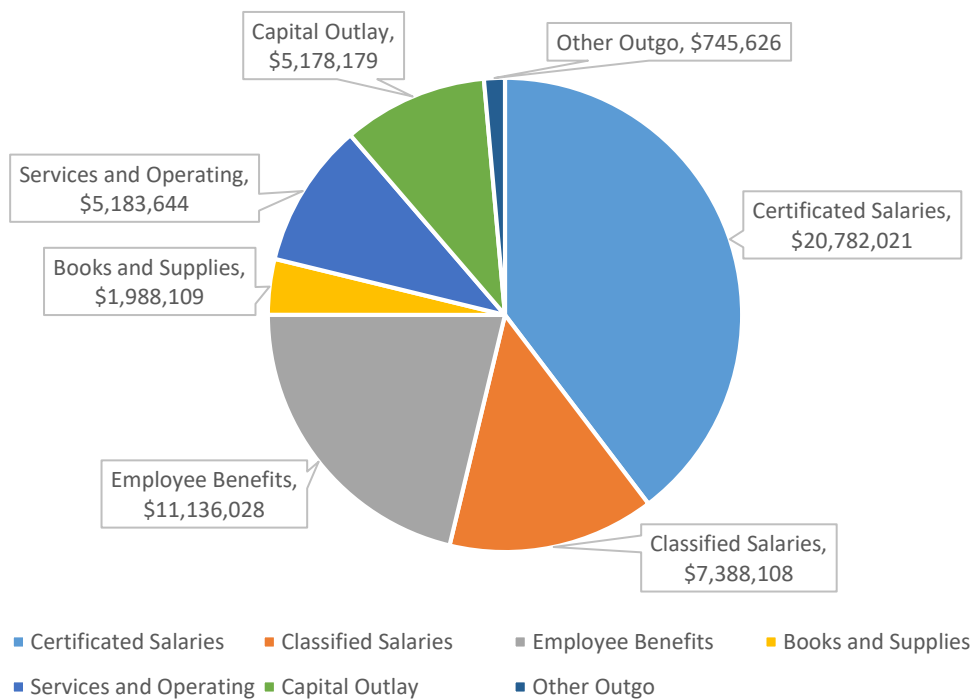
Revenue and Expenses
