#### **GENERAL PROVISIONS**

The Board of Education for the Town of Oxford, Connecticut (hereinafter referred to as Board), is seeking proposals from qualified vendors to provide transportation services to students from Oxford, CT to a variety of public and private schools outside of Oxford. These services will provide transportation to the school in the morning and returning students to their homes in the afternoon.

#### **Service Required**

#### **SCOPE OF WORK:**

#### **Summary**

Oxford Public Schools is seeking proposals from vendors, schools, and agencies to transport students from Oxford homes to schools outside of Oxford in the morning and return students to their homes from the same schools outside of Oxford in the afternoon. It is anticipated that vendors may submit proposals for either all transportation runs or a subset of the requested runs. The award to the bid will be done in whole or subsets in the best interests of the district.

#### **Anticipated Timeline**

Bidders must provide transportation services beginning approximately August 19, depending on the school.

Provide a detailed proposal for services, that includes but is not limited to

- o Cost per child per route
- o Cost for additional services
  - Car seat
  - Specialized equipment
  - Adult monitor on the vehicle
- In addition to the detailed quote, submit OPS Route Cost Sheet Appendix A
- Proposed contract for services, that includes but is not limited to
  - o In the event schools are shut down preventing the need to transport students on a short term or long term basis the district reserves the right to to pause or terminate the contract without due penalty for payments made on days not used as long as 48 hours are provided to suspend or cancel services.
  - o In the event that the student no longer requires transportation to the assigned school the district reserves the right to cancel or pause transportation services with 48 hour notice without due penalty for payments on future days not used.
  - o In the event that school days are not needed due to inclement weather or other unforeseen circumstances the district is not responsible for payment on lost days or days not made up later in the year. Invoices are contingent on days in operation of in-person school and not a preset 180 day school year.
  - o In the event the transportation services are delayed (due to vehicle or driver problems not related to traffic) causing a student to be late to school or be dropped off at home the district is eligible for a credit for that individual run.
  - o The vendor agrees to have its drivers exercise all required safety precautions for wearing FaceMasks at all times and implement other necessary safety precautions in its vehicles aligned to the requirements of the State of Connecticut and/or the local health agency.

The successful contractor awarded this bid will acquire any necessary permits required for the Scopes of Work listed above.

#### 1. PREPARATION OF PROPOSALS

#### 2. BID SUBMISSION

#### 3. BID TIME

Bids shall be received at the Oxford Board of Education, Central Office, prior to August 9 at 1:00pm. All bids will be opened and recorded by the Oxford Public School District Central Office on August 9 at 2:00 PM.

#### 4. TOWN'S OPTIONS

The BOE reserves the right to award the requirement as one contract or multiple contracts depending on the best interest of the Town and the Board of Education.

The Town reserves the right to reject any or all bids and to waive any requirements, irregularities, technical defects or service therein when it is deemed to be in the best interest of the Board of Education. The award shall be made after careful consideration of all factors including but not limited to price.

#### 5. TAXES

All purchases made by the Town, and associated with the award of this requirement shall be tax exempt. Any taxes must not be included in bid prices. A BOE Tax Exemption Certificate shall be furnished upon request.

#### 6. INQUIRIES

All inquiries regarding this request shall be answered up to the close of business on August 5, after which time no additional questions will be accepted. To ensure consistent interpretation of certain items, answers to questions the district deems to be in the interest of all bidders will be made available in writing on the district website.
