The Nadaburg Unified School District provides a device protection plan for students and parents utilizing take-home devices. Enrollment in the program is optional, with the understanding that if students/parents do not enroll in the protection plan, they may carry entire liability for the student device (Laptop or tablet), such as for other damaged or lost school property, such as textbooks.

<p>Program Fees and Coverage</p> <ul style="list-style-type: none"> • Premium: \$40 per school year. This fee is non-refundable and will not be prorated. • Limit Liability: \$250 per claim • Coverage: Repair or replacement of school-issued device and case. • Enrollment Deadline: Must enroll in the plan before August 15, 2024 or within 30 days of receipt of the device (If student is a new enrollment)
<p>Effective Coverage/ Expiration Date</p> <ul style="list-style-type: none"> • Effective Date: Coverage begins when the \$40 nonrefundable fee is paid. • Expiration Date: Coverage ends on the earliest of the following dates: last day of the school year, return of the device, no longer enrolled in school, or no longer qualified for the take-home device program. • Renew coverage before expiration to ensure coverage is always in effect.
<p>Coverage - The Optional Device Protection Plan coverage includes:</p> <ul style="list-style-type: none"> • Accidental damage caused by liquid spills, drops, or other unintentional events. • Loss of device due to theft; a valid police report must accompany the claim. • Fire damage: the claim must be accompanied by an official fire report from the investigating authority. • Damage due to an electrical surge. • Loss or damage caused by natural disasters.
<p>Exclusions - The Optional Device Protection Plan coverage excludes:</p> <ul style="list-style-type: none"> • Damage caused by dishonesty, fraud, intentional, negligent (stored in an insecure manner or location), or criminal acts. Students and parents will be responsible for the total repair/replacement for damage or loss in this category. • Damage incurred to a device not in the school-issued protective case when a case is provided. • "Jailbreaking" or otherwise voiding the manufacturer's warranty by altering the software. Jailbreaking is a term used to describe how normal manufacturer controls on the device's functionality are bypassed. Jailbreaking of school-issued devices is not permitted. Downloading non-district-approved software is not allowed. • The Nadaburg Unified School District is not liable for any loss, damage (including incidental, consequential, or punitive damages), or expense caused directly or indirectly by the equipment.
