Pickens Academy accepted services provided through GEER. The Headmaster, Brach White elected to participate on June 18, 2020. Pickens Academy will received services in the amount of \$1,191.89 to provide instructional supplies to meet the needs of identified students. Mr. White elected not to use the funds to improve remote learning or to support technical capacity and access. The district will use the set-aside funds in the amount of \$132.43 for office supplies for the administration of the program. All services will conclude by September 30, 2022.

The district will purchase Edgenuity and Smarty Ants for student use. Edgenuity will also be used to provide a credit recovery option for students in grades 7-12 beginning the second semester. These students will be assessed and provided instruction in identify areas of need. LEA will communicate with parents to provide student progress during summer school.

How will the LEA plan for implementation and measure impact for effectiveness for purchases identified?

Students will be assessed to identify areas of improvement. Individual Improvement Plans will then be developed to ensure students are able to meet the standards. Teachers will be provided professional development to ensure the implementation of the various program to fidelity. District policies will be followed when making purchases.

What is the proposed timeline for providing services and assistance to students and staff?

Teachers will be trained on Edgenuity on the professional development days following the Christmas break. Students will being using the program on January 7, 2021 when they return. Kindergarten through third grade students will participate in at least 70 hours of summer school. Other grades will participate in summer school for at least 4 weeks. All services will conclude by September 30, 2022.

All teachers and paraprofessionals will participate in professional development that will assist them in providing blended and virtual learning for students. The various professional development opportunities will focus on iStations, Stride Academy, Edgenuity, Schoology, Schools PLP, and Google Meet. If any barriers occur, LEA will handle as needed.
