Upon a motion by Parrish King and seconded by Charles Eldridge, this was approved.

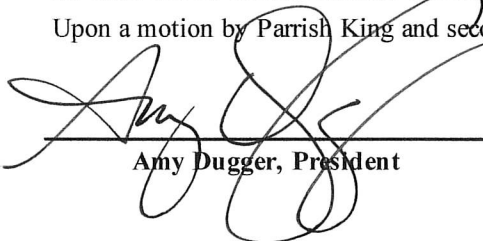

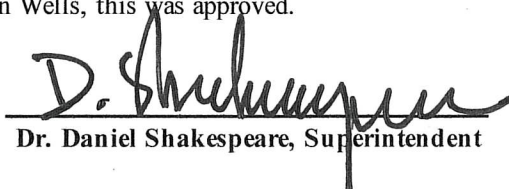
