Uptmor explained that the gym floor at GU was covered with 600 sheets of plywood during the seismic grant work. The district would like to declare this excess property and sell it. Stokes asked Uptmor if he could do a minimum bid or something so the district wouldn't be "giving" the plywood away. Uptmor said he would look into that.

Walker moved to declare the excess plywood from the GU Seismic work as excess property. Wyllie seconded. The motion passed with 5 for; 0 opposed.

#### 3.2 Co-op's –Current Process Described

Gerry handed out a packet with a list of co-ops the district had entered into in the past along with OSAA guidelines. Uptmor said that Gerry had asked Uptmor to put this item on the agenda because we don't currently have a process for the co-ops. Gerry said that he only included the past 6 years because that is all the further the OSAA website will give you. Gerry went over the handout and said he feels this needs to be a discussion with the board so that moving forward we can have a process. Cronin clarified that we would have to include the entire schools ADM even if we only get a couple kids from the other school. Gerry said that was correct. Gerry said the current cutoff for 2A is 206 students. Hall asked if a student from Dayville wanted to do golf could they practice with us and then compete individually. Gerry said that was not allowed by OSAA and the student would be ineligible. McCumber asked what our current enrollment was. Hall said that having guidelines in place can sometimes be a curse if you set them and then don't follow them. Hall agreed that there should be some put into place but at the same time there should also be some flexibility with them. Cronin said that if we're here for kids she thinks that we should allow kids from other schools to participate with us if we have the capability. Cronin said that she didn't think we should bump up into another league however. Walker asked why. Gerry said that we will be the small fish in the league if we were to do that plus that would increase our travel. Walker said that in the OSAA guidelines that Gerry handed out she is not seeing that moving into a different level was a good enough reason not to allow a student to compete in a sport. Uptmor said the board approves the co-op. He continued, if we establish guidelines than the board has a reason to make the decisions to approve or not approve. Walker said she would like to see some sort of justification for not moving up to another level. She continued if it benefits the students and our teams at GU then why would we say no. Walker suggested asking other schools if they have any co-op guidelines they could share with us. Gerry said that he had actually contacted other schools and they did not have anything either. Walker said that this subject has been brought to her attention so she wanted to thank Gerry and Uptmor for bringing it to the board. Gerry asked Colson if they had any set guidelines at Prairie. Colson said they did not. Colson went on to say that they were approached by Burnt River to coop for football and that the Superintendents, athletic directors and Prairie's football coach all agreed to the co-op because it was the only way that the Burnt River kids would get to play. Gerry said that we have had a good relationship with Prairie over the years and have co-oped with them for the past few years. Gerry asked if another school asks first though, do you allow the other school and deny Prairie. Cronin said that she thinks if we have a historical relationship with a school we should honor that history. Cronin continued that if a new school were to ask for a co-op we should still continue the relationship with the school we have history with as well. Walker said she likes the historical agreement concept. Walker asked what GU gets as far as compensation from the co-ops. Colson said that the scale was as follows: for 1-5 students GU gets \$500; for 6-10 students GU gets \$1,000. Cronin said she likes giving opportunities to the kids in the county. Uptmor said this was good input for Gerry and that he could now go back and work on the guidelines they've given. Wyllie asked what Gerry would be doing with the guidelines. Gerry said he would be getting the process lined up and then sharing that with the other schools when they ask.

#### 3.3 Board and Superintendent Working Agreement

Cronin stated that at the OSBA training on August 5<sup>th</sup>, Renee Sessler gave a facilitated assessment on the current agreement. Cronin explained to the new board members what the working agreement was. Cronin suggested moving the "Student First Principle" out of the Board Expectations for the Super and move that to #5 under collaborative governance. Cronin further suggested replacing the "Student First Principle" with "Decisions and management undertaken by the board and superintendent will always be made considering students first."

Hall moved to approve the Board and Superintendent Working Agreement with the proposed changes. Wyllie seconded. The motion passed with 5 for; 0 against.

Walker asked how #2 under "communication agreements" works. Cronin explained the thinking behind this statement. This statement basically gives the Superintendent a heads up so they can find the answer to the questions before the meeting and then present the answers at the meeting when the questions are asked.

## **Cooperative Sponsorship Application**

### Excerpt OSAA Handbook, Executive Board Policies, Cooperative Sponsorship

(Revised Fall 2015)

In order for two or more schools to qualify for cooperative sponsorship as permitted in Article 6.5., they must meet the following requirements:

- A. Who May Apply. Only full member schools may apply for cooperative sponsorship, not families or individuals. Cooperating schools should be located in the same geographic area. Schools requesting cooperative sponsorship approval should make every effort to co-sponsor an activity with the nearest school that also has difficulty sponsoring the activity by itself. Cooperative sponsorship shall be considered only for 4A, 3A, 2A and 1A schools.
  - **EXCEPTION:** The Executive Board also may approve cooperative sponsorships involving 4A, 3A, 2A or 1A schools with a 6A or 5A school if the 4A, 3A, 2A or 1A schools are located in an isolated area, are unable to find a closer 4A, 3A, 2A or 1A school willing to enter into a cooperative sponsorship agreement, or if the two schools are physically housed in the same building where students take classes together.
- B. <u>Classification</u>. Classification placement for the requested activity will be determined by the total combined ADM in grades 9-12 of the schools involved.
  - **EXCEPTION:** If the total combined ADM in grades 9 through 12 causes the cooperative team to qualify for a higher classification, the schools requesting permission for a cooperative team may petition the Executive Board for an exception to this provision. Factors that may be considered by the Executive Board when evaluating a petition for an exception may include, but are not limited to, number of participants from each school, how much the combined ADM exceeds the classification cutoff point, and geographic considerations.
- C. <u>School Board Approval Requirement</u>. The Governing Boards of the schools involved in the cooperative sponsorship shall jointly apply for such sponsorship listing reasons for the request.
- D. Regular or Special District Approval Requirement. Cooperative sponsorship applicants shall obtain approval from the regular or special district in which the proposed cooperative team will participate and submit the approval form with the Cooperative Sponsorship Application. Regular and special districts are encouraged to consider the philosophy discussed at the end of this Executive Board Policy when reviewing requests for support of a cooperative sponsorship application.
- E. <u>Deadline for Application/Dissolution</u>. The deadline for application or for dissolution for a cooperative sponsorship shall be the first contest date of the season in which the cooperatively sponsored team is to compete.
- F. <u>Timeline for Approval</u>. The Executive Board will attempt to act on an application at its next regular meeting following receipt of the application. However, the Executive Director can make a decision, subject to approval by the Executive Board.
- G. <u>Duration of Approval</u>. Any approved cooperative sponsorship shall be limited in duration to the remainder of the time block per application. If an application for cooperative sponsorship is granted for multiple years and the cooperating schools choose not to cooperatively sponsor a team during any year of the agreement, it will be necessary for the schools to reapply for permission to cooperatively sponsor a team during the remaining term of the agreement using the most recent ADM figures available.

### Excerpt OSAA Handbook, Constitution, Article 6.5 – Cooperative Sponsorship

6.5.2. Classification placement for the requested activity will be determined by the total combined ADM in grades 9 through 12 of the schools involved.

**EXCEPTION**: If the total combined ADM in grades 9 through 12 causes the cooperative team to qualify for a higher classification, the schools requesting permission for a cooperative team may petition the Executive Board for an exception to this provision. Factors that may be considered by the Executive Board when evaluating a petition for an exception may include, but are not limited to, number of participants from each school, how much the combined ADM exceeds the classification threshold, and geographic considerations.

# Oregon Schools Athletic Association (OSAA) Cooperative Sponsorship Philosophy

The philosophy that will guide the OSAA Executive Board in reviewing and approving applications for cooperative sponsorship of activities is as follows:

- A. The Executive Board will attempt to increase the number of students who are participating in activities by making activities available for students that would not be available in their school because of a lack of numbers if joint sponsorship did not occur.
- B. The Executive Board would prefer to see projects that combine smaller schools for sponsorship of an activity rather than a small school program combining with a larger school when the smaller school cannot support the activity alone because of a lack of numbers.
- C. Improving the quality of a team (e.g., better won-lost record) will not be a valid criterion in deciding whether approval should be granted.

Walker said that it is obvious the impact Romero had on the student athletes and she did a good job but unfortunately we are responsible for the decisions we make. Walker continued that one of the board's priorities is "Safe and Secure Schools" and that means protecting the students so she agreed with the termination.

Cronin said that she always roots for people to have a second chance and she thinks that Romero will have that but she thinks that the administration acted properly and gave her due process. Cronin said that even though Romero is considered an at-will employee she is still entitled to certain steps and those were adhered to by the administration.

Hall asked if there is room for Romero to demonstrate to the administration that she has learned from this experience and have an opportunity to coach again. Uptmor said that he had a conversation with Romero and told her what she would need to do to prove that she is ready to come back. Uptmor said that the district will support Romero in her path but this is not the direction he would recommend to her right now.

Stokes moved to uphold the decision to dismiss Ashleigh Romero as Grant Union's Dance Coach. Hall seconded. The motion passed with 6 for; 0 opposed.

#### 6.0 OLD BUSINESS

6.1 GU Automotive Shop Update

Uptmor said that there has been a little bit of progress made on the shop this week. Uptmor said that there is some sheetrock hung and that there is a tarp covering up some of the insulation. Gerry said that he did talk to the contractor, Brian Hubbard, last Tuesday and he said that he will have his portion of the project completed by this Friday. Gerry said he wasn't sure if this was going to happen or not but he does have the other subcontractors lined up to complete their portions of the project as soon as Hubbard is done.

6.2 Co-op's Process Update

Gerry told the board that he is hoping this can be the final co-op protocol because he felt it was important to have something in place. Gerry said that through this process he has talked to other athletic director's and after talking to Gerry they have realized how important it is to have some sort of protocol in place. Gerry said that the biggest change to the current protocol is the \$2500 fee that they are charging the other schools now. Gerry said that it was currently \$500 per student but that didn't cover everything that Grant Union provides; coaches, transportation, uniforms, etc. Gerry said that the other change is the addition of the expected student behavior section. Robertson asked how this protocol would apply to homeschool students. Gerry said that it doesn't because there are different requirements for them. Robertson then asked about online students. Gerry said that they also have a separate agreement for students that live in our district but attend online classes. Robertson asked how much it costs for online students to participate in sports. Gerry said that it was based on a percentage of the ADM so currently it is around \$400 per student.

Uptmor said that he's been an administrator for 20 years and this is one of the hardest things for administrators to negotiate with other schools. Uptmor said he's been asking for some sort of protocol for several years and that Gerry doing this made him feel good that Grant School District will probably be the first in the state with a protocol and will probably be a model for other districts in the state. Uptmor said that he was proud of our district for taking the lead on it.

Cronin said that she agreed with Uptmor's statement and liked that the protocol was a one-page guide which would make it easy to follow.

## **Cooperative Agreement Protocol**

- 1. Request for cooperative sponsorships needed to be made prior to Aug 1<sup>st</sup> for the upcoming calendar year.
- 2. Cooperative Sponsorship will not be considered during the active OSAA calendar year.
- 3. Grant School District 3 will not enter into a cooperative agreement if, in doing so, it moves Grant Union High School into a higher classification.
- 4. Cooperative agreements will be on a one-year agreement.
- 5. Cooperative agreements are for OSAA sanctioned sports only.
- 6. Agreements for Cooperative Sponsorship will be entered into with the intention of increasing participation numbers to field both Varsity and/or Junior Varsity teams.
- 7. The recommendation from the head coach of the sport in which the cooperative sponsorship is being applied for will be considered when reviewing cooperative agreement applications.
- 8. The associated fee for entering into a cooperative agreement will be \$2,500 per sport. Payment of fee is expected upon approval of cooperative agreement.
- 9. For all cooperative agreements, the team identifier as listed in OSAA will be as Grant Union Prospectors.
- 10. Students participating in cooperative agreements will:
  - a) Be required to follow all rules and regulations that are outlined in Grant School District 3 policy, Grant Union Athletic Handbook, and Grant Union Student Handbook.
  - b) Adhere to Grant Union High School attendance policy.
  - c) Be required to follow all rules and regulations governed by the OSAA.
  - d) Be subject to Grant School District 3 drug testing policy and procedures.
  - e) Be classified as full-time student and supply current transcript to demonstrate they are on track to graduate.
  - f) Supply current academic progress and/or grade check forms, verified by the home district, when requested by Grant School District 3.

First of all, thank you all for your commitment to the youth of our community especially during these trying times. The purpose of this letter is to express our concerns for continuing the cooperative agreements with other neighboring schools in athletics.

As coaches in this district, our focus is to extend the classroom into the athletic arenas and enrich the overall experience of junior high and high school students that attend our schools. In previous years, we have welcomed the cooperative agreements in some sports in order to field full JV and Varsity programs that we may not have been able to field without a co-op. In recent years, the dynamic has shifted. The numbers of Grant Union participants in these sports has stabilized and we feel that we should focus solely on creating opportunities for Grant Union students and not those of neighboring schools. As we all know, four years of high school flies by, and there are a finite number of opportunities in athletics for our students. As long as we have the appropriate number of student athletes to continue fielding complete teams, we should reserve the opportunity to be a Prospector for the student athletes that have chosen to attend our schools. If students from neighboring schools want to participate in any of our interscholastic programs, they are free to enroll with Grant School District #3.

We must continue to improve and refine our approach to the dynamic state of education. This includes athletics, and at this time, we feel that cooperative agreements in athletics with neighboring schools is not best for our students.
