#### **Open Session**

#### Call to Order

Board Chairman, T. McDonald called the meeting to order at 6:30 p.m.

#### **Moment of Silence**

The Board observed a moment of silence before beginning the meeting.

#### Pledge of Allegiance

#### Comments by Board Chair, Board Members, and Superintendent

T. McDonald, Board Chairman spoke of attending an activity at Wheatmore High involving students in cheerleading and gymnastics from ages three through high school age. Mr. McDonald will begin visiting elementary schools to distribute and provide socks to students. T. Cutler spoke of recent visits to open houses, Randolph County Partnership for Children, and commissioner's meeting. Mr. Cutler expressed many thanks to Amy Kidd for her recent recognition as the NC Agriculture cohort teacher of the year for the 2013-2014 school year. He also highlighted the following: Randleman High receiving ejection free for the 2012-2013 school year from the NCHSAA, October 30, 2013 antibullying day (wear orange), and commended the schools on their outstanding job on their websites and expressed appreciation for their hard work.
