**FEBRUARY 18, 2025 REGULAR BOARD MEETING**

The Regular Meeting of the Chadwick-Milledgeville Community Unit School District #399 Board of Education was held at the Milledgeville School on Tuesday, February 18, 2025 at 7:04 p.m.

**MEMBERS PRESENT:** S. Baylor-Schmidt, M. Bibler, A. Drinkall, P. Eubanks, T. Hackbarth, and M. Urish. B. Smith was absent.

**CALL TO ORDER:** The meeting was called to order by the Board President, P. Eubanks. A motion was made by M. Urish and seconded by A. Drinkall to approve the agenda. Voice vote showed 6 ayes and no nays. Motion carried.

Superintendent Schurman reported that we received two bids and the low bid was from Sjostrom & Sons for \$395,292. This is an expensive project and the board should be aware that it may require spending some of our reserves out of the Operations & Maintenance Fund.

**First Reading Proposed 2025-26 District Calendar.**

This calendar is like recent school calendars. We start Monday, August 11, 2025, with two Institute Days. Students start August 13, 2025. Thanksgiving Break is November 24-28, 2025. Christmas Break is December 22-January 4, 2026. Spring Break is separate from Easter, March 16-20. For Easter students are off Good Friday, April 3, 2026. The last day for students will be Thursday, May 21, 2026, and the last day for teachers will be Friday, May 22, 2026.
