Not providing consent to use Google services in an educational setting can significantly impact a student's experience in several ways:

- Limited Access to Assignments and Materials Many schools rely on Google Classroom, Docs, Slides,
 Drive for sharing assignments, lectures, resources like Google Maps and Chrome Remote Desktop. Students
 without access may need alternative ways to receive and submit work, such as email, printed materials, or
 different platforms.
- Collaboration Challenges Google services facilitate real-time collaboration through Docs, Sheets, and Meet. Without access, students may need to use other tools like Microsoft Office, Zoom, or local applications, which may not integrate as smoothly with school systems.
- 3. **Difficulty in Communication** Many schools use Gmail or Google Chat for official communications. Without access, students may miss important announcements or need to rely on personal email accounts that might not be included in school-wide communications.
- Incompatibility with School Systems The school is heavily integrated with Google services, using
 alternative software might cause technical difficulties, such as formatting issues when submitting
 assignments or limited access to shared resources.
