Sacred Heart School is committed to making a Catholic education accessible to all families, including those who may not be able to meet the full tuition cost. Tuition increases, while necessary due to rising educational expenses, are not intended to exclude anyone. To support this mission, the school administration is available to meet with families who have concerns regarding any or all financial obligations.

STANDARD PAYMENT POLICY

Please read each statement below carefully. Initial next to each item to indicate your understanding and agreement:

_____ **Tuition Payment Options:** Tuition may be paid as a single annual payment due in August, semi-annual payments due in August and January, or monthly installments beginning in June or July. All payments must be scheduled through FACTS.

_____ **Late or Declined Payments:** Late payments will incur an automatic late charge. Any payment declined by the bank will result in a \$25 returned payment fee. If tuition is past due and no satisfactory arrangement has been made, parents will be contacted by school administration. Continued noncompliance may result in being asked to withdraw child/children from the school.

_____ **Tuition Policy:** No deductions will be made for days missed. Tuition must be paid in full by April 30th; report cards and awards may be withheld until all tuition and fees are paid. Students transferring to another school must have all tuition and fees paid in full. Tuition for the month of transfer is earned and non-refundable; any prepaid tuition beyond that month will be refunded.

_____ **Parent Involvement Hours:** Each family is required to complete 20 Parent Involvement Hours during the school year. Unfulfilled hours will be billed at \$125 per hour. Families are responsible for ensuring all hours are properly logged (on-campus, off-campus, or during field trips).

_____ **Hot Lunch Requirement:** All families must complete two hot lunch shift dates, even if they have already fulfilled their 20 Parent Involvement Hours. These shifts count toward the required 20 hours. A \$250 penalty will apply for each uncompleted shift.

_____ **SCRIP Requirement:** Each family must generate a minimum SCRIP profit of \$300 by May 31st. If the requirement is not met, families will be billed double the remaining balance, with any outstanding amounts invoiced during the summer.

_____ **FFA Fundraising:** Each family is required to contribute a total of \$700 through fundraising activities by the last day of the school year. If the requirement is not met, any outstanding amounts will be billed during the summer.

_____ **Supplies:** Students are required to provide basic school supplies. A list will be included in the summer information packet.

_____ **Uniforms:** Students are required to wear school uniforms. Policy details are available in the Parent/Student Handbook and at the school office.

SINGLE PARENT FAMILY FUNDRAISING POLICY

Sacred Heart School recognizes that certain circumstances may affect a family's ability to fulfill fundraising requirements. For this reason, the Parent Involvement and Fundraising Programs include an allowance for "Single Parent Families." For eligible families, the fundraising and parent involvement requirements are reduced by half (\$350 FFA; \$150 SCRIP; 10 Parent Involvement Hours), and families are required to complete 2 Hot Lunch shift dates. All other Fundraising Program policies still apply.

A "Single Parent Family" is defined as:

One parent, not living with a spouse or partner, who has full day-to-day responsibility for raising the child/children, is the sole caregiver, has the child/children residing with them full-time, and is 100% financially responsible for the child/children, with no involvement from a second parent.

If you meet these criteria, please provide a brief explanation in the space below, sign, and return this form to the school office along with your signed Tuition Agreement. This information will be kept confidential by Sacred Heart School administration.

\$350 FFA, \$150 SCRIP profit, completion of 10 Parent Involvement Hours, and 2 Hot Lunch shifts.
